GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 6(2) of the Consumer Credit (Tasmania) Act 1996

This proclamation amends the Consumer Credit (Tasmania) Regulations in conformity with the Consumer Credit (Bill Facilities) Amendment Regulation (No. 1) 2007 of Queensland.

(2) Juries Amendment Regulations 2008

These regulations amend the Juries Regulations 2005 by-

- (a) increasing the remuneration to be paid to unemployed persons who attend court for jury service; and
- (b) increasing, and indexing annually, the remuneration to be paid to employed or self-employed persons who attend court for jury service.
 - (3) Sentencing Amendment Regulations 2008

These regulations amend the Sentencing Regulations 1998 by prescribing 31 July 2008 as the cut-off date for the making of drug treatment orders under Part 3A of the Sentencing Act 1997.

(4) Poisons List Amendment Order 2008

This order amends the Poisons List Order 2001 by incorporating changes recommended by the National Drugs and Poisons Schedule Committee in the Standard for the *Uniform Scheduling of Drugs and Poisons No. 22, Amendment No. 3*.

(5) Poisons (Prohibited Substances) Amendment Order 2008

This order amends the *Poisons (Prohibited Substances) Order 1990* by amending the entry for levomethorphan in the list of prohibited substances.

(6) Threatened Species Protection Order 2008

This order amends the Threatened Species Protection Act 1995 by-

- (a) adding certain species to, and omitting certain species from, the Schedules of endangered, vulnerable and rare flora and fauna: and
- (b) updating certain taxonomic, authority, family and common name references in the Schedules; and
- (c) updating the item numbering and format of Schedules.
