### REVOCATION OF STATE POLICY ON THE PROTECTION OF AGRICULTURAL LAND 2000

I, THE GOVERNOR in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, acting with the advice of the Executive Council and on and in accordance with the recommendation of the Premier do, under section 11 of the *State Policies and Projects Act 1993* and section 22 of the *Acts Interpretation Act 1931*—

- a) revoke the Tasmanian Sustainable Development Policy known as the State Policy on the Protection of Agricultural Land 2000 made on 4 September 2000 and notified in the Gazette on 4 September 2000; and
- b) declare that the revocation takes effect at the end of the day on which the revocation has been approved by the second of both Houses of Parliament.

### NOTICE UNDER SECTION 12 OF THE STATE POLICIES AND PROJECTS ACT 1993

I, THE GOVERNOR in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, acting with the advice of the Executive Council, being satisfied on the recommendation of the Premier that it is necessary that the Draft State Policy known as the Draft State Policy on the Protection of Agricultural Land 2008 and which is on public exhibition at the office of the Resource Planning and Development Commission (and a copy of which is set out in Schedule 1 to this notice) should come into operation as a State Policy without delay, by this my notice under section 12 of the *State Policies and Projects Act 1993* declare—

- a) that the Draft State Policy known as the Draft State Policy on the Protection of Agricultural Land 2008 is to come into operation on a temporary basis as a State Policy on the day after the day on which the revocation, dated 16 June 2008, of the State Policy on the Protection of Agricultural Land 2000 (made on 4 September 2000 and notified in the Gazette on 4 September 2000 under section 11 of the *State Policies and Projects Act 1993*) takes effect; and
- b) that any reference within the Draft State Policy on the Protection of Agricultural Land 2008 to the commencement of the Policy shall be taken to be the day on which the Draft State Policy commences operation by virtue of this notice; and
- c) that the *Acts Interpretation Act 1931* applies to the interpretation of this notice as if it were by-laws.
