### LIVING MARINE RESOURCES MANAGEMENT ACT 1995

#### DECLARATION OF A QUOTA MANAGEMENT

I, CRAIG MIDGLEY, performing the duties of Director (Marine Resources) in the Department of Primary Industries and Water, pursuant to the delegated authority of the Minister under section 20(1) of the *Living Marine Resources Management Act 1995*, in accordance with section 93 of that Act, hereby declare that:—

1. The species banded morwong (*Cheilodactylus spectabilis*) is to be subject to quota management under a management plan, namely the *Fisheries (Scalefish) Rules 2004* in that part of the scalefish fishery that includes State waters (other than the Tamar River) off the north, east and south coasts of Tasmania within the area bounded—
  - (a) in the north by line of latitude 40 degrees 40 minutes South; and
  - (b) in the west (for waters off the south coast) by an imaginary straight line starting at Whale Head and running south; and
  - (c) in the west (for waters off the north coast) by an imaginary straight line starting at Low Head and running north.
2. The 28th February 2006 is the date after which the quantity of fish caught as specified in records kept under Part 6 of the *Living Marine Resources Management Act 1995* is not relevant to any determination of an allocation of quota.
