> Forestry Tasmania Hobart, 27 January 2010

PROCLAMATION UNDER THE FORESTRY ACT 1920

- I, THE GOVERNOR in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, acting with the advice of the Executive Council, by this my proclamation made under sections 15 and 20 of the Forestry Act 1920 -
- (a) revoke that part of the Springfield Forest Reserve dedicated as a forest reserve for the conservation of public recreational use; and the preservation or protection of features of the land of aesthetic, scientific or other value; and the preservation or protection of a species of flora or fauna as contained in the proclamation notified in the Gazette on 19 December 1984 on page number 3001 and specified in Item 1 of Schedule 1 to this proclamation; and
- (b) revoke the dedication as State forest of the land referred to in paragraph (a); and
- declare that this Proclamation takes effect on the day on which its making is notified in the Gazette.
