### ANTI-DISCRIMINATION ACT 1998

#### OFFICE OF THE ANTI-DISCRIMINATION COMMISSIONER, TASMANIA EXEMPTION/S GRANTED

THE following exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

Anglicare Tasmania Inc - (11/153) - Exemption granted under section 57 of the Act for a period of 3 years.

#### PUBLIC NOTICE – TOTAL ALLOWABLE CATCH FOR THE ROCK LOBSTER FISHERY FOR THE 2012-2013 QUOTA PERIOD

I, BRYAN ALEXANDER GREEN, Minister administering the *Living Marine Resources Management Act 1995*, pursuant to Section 94 of that Act, for the quota period from 1 March 2012 to 28 February 2013, hereby:

1. **Set the total allowable catch for the commercial rock lobster fishery and the recreational rock lobster fishery combined at 1,273.24 tonnes;**
2. **Determine that the parts of the fishery from which the total allowable catch is to be taken are the commercial rock lobster fishery and, the recreational rock lobster fishery;**

3. **Determine that the portion of the total allowable catch to be taken from the commercial rock lobster fishery is 1,103.24 tonnes; and,**

4. **Determine that the portion of the total allowable catch to be taken from the recreational rock lobster fishery is 170 tonnes.**

Expressions used in this Public Notice have the same meaning as in the *Living Marine Resources Management Act 1995* and the *Fisheries (Rock Lobster) Rules 2011*.

### MOTOR VEHICLE TRADERS ACT 2011

#### CALL FOR SUBMISSIONS – REGULATORY IMPACT STATEMENT – MOTOR VEHICLE TRADER LICENSING FEE

THE Director of Consumer Affairs and Fair Trading invites interested parties to provide comment on the proposed licensing fee for motor vehicle traders.

*The Motor Vehicle Traders Act 2011* (the Act) is scheduled to commence on 1 April 2012 and replaces the former Motor Vehicle Code (the Code). The Act was introduced after a long period of consultation and policy development and was passed by the Tasmanian Parliament in mid-2011.

The Act includes many of the Code provisions but expands the warranty provisions and adds new requirements for pre-sale disclosure. The Act also creates enforcement powers and establishes new consumer remedies.

The *Motor Vehicle Trader Regulations 2011* (the Regulations) have been developed to support the implementation of the Act. The Regulations detail licence fees, exemptions from the Act, penalties for non-compliance with the Act and specify the requirements for pre-sale disclosure statements.

A Regulatory Impact Statement (RIS) has been prepared to specifically examine the impact of the proposed licence fee on motor vehicle traders.
