GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Electricity Supply Industry (Price Control and Related Matters) Amendment Regulations 2012

These regulations amend the *Electricity Supply Industry (Price Control and Related Matters) Regulations 2012* to allow the making of a determination in respect of the maximum amounts chargeable, between 1 July 2013 and 31 December 2013, in respect of the retailing of electricity to tariff customers on mainland Tasmania, without holding a prior investigation or otherwise complying with Part 2 of those regulations, and specifying the provisions that such a determination is to contain.

(2) Food Regulations 2012

These regulations -

- (a) incorporate the Food Standards Code for the purposes of the *Food Act 2003*, with the exception of Standard 3.3.1 of that Code as it applies to certain child care centres; and
- (b) provide food-handling requirements for those child care centres to which Standard 3.3.1 of the Food Standards Code does not apply; and
- (c) define the appropriate enforcement agencies for the purposes of the Food Standards Code; and
- (d) prescribe the offences for which infringement notices may be served under the *Food Act 2003* and the *Food Regulations 2012* and the relevant penalties for those offences; and
- (e) rescind the Food Regulations 2003, the Food Amendment Regulations 2007, the Food Amendment Regulations 2008 and the Food Amendment Regulations 2009.
 - (3) Proclamation under section 42 of the Irrigation Company Act 2011

This proclamation fixes 26 October 2012 as the day on which the *Rivers and Water Supply Commission Act 1999* is repealed and the Proclamation under the *Rivers and Water Supply Commission Act 1999* is revoked.

(4) Liquor Licensing (Fees) Amendment Regulations 2012

These regulations amend the *Liquor Licensing (Fees) Regulations 2005* by increasing the fees payable for annual liquor licences and liquor permit applications.

(5) Proclamation under section 11(2) of the Nature Conservation Act 2002

This proclamation, made under the Nature Conservation Act 2002 -

- (a) declares certain areas of Crown land to be reserved land in the class of conservation area; and
- (b) in doing so, creates and names certain new conservation areas and extends certain existing conservation areas.
