GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the Building Amendment Act 2012

This proclamation fixes 28 November 2012 as the day on which the provisions of the Building Amendment Act 2012 commence.

(2) Building Amendment Regulations 2012

These regulations amend the Building Regulations 2004, consequent on the enactment of the Building Amendment Act 2012, by -

(a) clarifying the types of work that are prescribed as building work; and

- (b) extending the types of buildings or building work exempted from a building permit; and
- (c) consolidating the types of temporary structures exempted from a temporary occupancy permit; and
- (d) substituting the Schedule relating to infringement notice offences; and
- (e) making miscellaneous minor amendments of an administrative nature.

(3) Plumbing Amendment Regulations 2012

These regulations amend the Plumbing Regulations 2004 -

- (a) consequentially on the enactment of the Building Amendment Act 2012; and
- (b) in relation to an exemption for the installation of energy-efficient heated water services; and
- (c) to make other minor miscellaneous amendments.

(4) Conveyancing and Law of Property (Building Title Plans) Regulations 2012

These regulations -

- (a) provide for various matters in relation to building title plans under Division 2 of Part XI of the *Conveyancing and Law of Property Act 1884*; and
- (b) are made consequentially on the repeal of the *Conveyancing and Law of Property (Building Title Plans) Regulations 2002* under section 11 of the *Subordinate Legislation Act 1992*.

(5) Conveyancing and Law of Property Regulations 2012

These regulations -

- (a) provide for various matters in relation to applications under sections 84B, 84C and 84D of the *Conveyancing and Law of Property Act 1884*; and
- (b) are made consequentially on the repeal of the *Conveyancing and Law of Property Regulations 2002* under section 11 of the *Subordinate Legislation Act 1992*.

(6) Proclamation under section 2 of the Explosives Act 2012

This proclamation fixes 1 January 2013 as the day on which the Explosives Act 2012 commences.

(7) Guardianship and Administration Amendment (Fees) Regulations 2012

These regulations amend the *Guardianship and Administration Regulations 2007* by including provisions requiring fees to be paid in relation to various matters under the *Guardianship and Administration Act 1995* and by permitting the Guardianship and Administration Board to waive any of those fees in whole or in part.

(8) Proclamation under section 2(2) of the Justice and Related Legislation (Miscellaneous Amendments) Act 2012

This proclamation fixes 1 December 2012 as the day on which Part 21 of the Justice and Related Legislation (Miscellaneous Amendments) Act 2012 commences.

(9) Land Titles Regulations 2012

These regulations –

- (a) prescribe various matters for the purposes of the *Land Titles Act 1980*, including the manner in which dealings and applications are to be lodged for registration with the Recorder of Titles; and
- (b) are made consequentially on the repeal of the Land Titles Regulations 2002 under section 11 of the Subordinate Legislation Act 1992.

(10) Local Government (General) Amendment Regulations 2012

These regulations amend the Local Government (General) Regulations 2005 by -

- (a) increasing the allowances of all councillors, deputy mayors and mayors of the Kentish Council; and
- (b) providing that councils do not need to tender for the provision or supply of certain goods or services that are obtained as a result of a tender process conducted by certain other bodies; and
- (c) effecting minor statute law revision.

(11) Registration of Deeds Regulations 2012

These regulations -

- (a) make provision in respect of various matters relating to the lodgment or registration of documents under the *Registration of Deeds Act 1935*; and
- (b) are made consequentially on the repeal of the *Registration of Deeds Regulations 2002* under section 11 of the *Subordinate Legislation Act 1992*.
