Food

FOOD ACT 2003

Section 86(1) Notice

REQUIREMENT TO REGISTER FOOD BUSINESS

I, DR ROSCOE TAYLOR, being and as Director of Public Health appointed pursuant to section 6 of the *Public Health* Act 1997 and acting pursuant to section 86(1) of the Food Act 2003 (the Act), hereby require the proprietor of a food business that handles or sells potentially hazardous food to register that business under the Act. Failure to comply with this requirement is an offence under section 86(2) of the Act.

In this notice -

Potentially hazardous food means food that has to be kept at certain temperatures to minimise the growth of any pathogenic micro-organisms that may be present in the food or to prevent the formation of toxins in the food.

Food business means a business, enterprise or activity that involves:

- (a) the handling of food intended for sale; or
- (b) the sale of food

regardless of whether the business, enterprise or activity concerned is of a commercial, charitable or community nature or whether it involves the handling or sale of food on one occasion only, and includes, but is not limited to, a:

- (i) restaurant, bakehouse or café;
- (ii) snack bar or takeaway;
- (iii) retail meat or fish shop;
- (iv) market stall or mobile food business;
- (v) community or delivered meals organisation;
- (vi) distributor, importer, packing or storage facility;
- (vii) manufacturer or processor;
- (viii) canteen or child care facility:
- (ix) hotel, motel or guesthouse; or
- (x) hospital, nursing home or prison.

but does not include a business, enterprise or activity that involves only:

- (xi) primary food production;
- (xii) food vending machines;
- (xiii) a vehicle used to transport food;
- (xiv) a vessel specified in a licence issued pursuant to the Living Marine Resources Management Act 1995 from which fish is not sold direct to the public;
- (xv) activities where food preparation is taught unless the activity involves the handling of food intended for sale or the sale of food for human consumption;
- (xvi) food provided by a family day care educator

pursuant to the Education and Care Services National Law (Tasmania); or

(xvii) the selling, packing, storing, transporting or distribution of pre-packaged food and/or unprocessed fruit, vegetables, grain or eggs;

nor does it include a business, ≠enterprise or activity that:

- (xviii) forms part of or is otherwise attached to licensed meat premises within the meaning of the Meat Hygiene Act 1985; or
- (xix) forms part of or is otherwise attached to dairy premises within the meaning of the Dairy Industry Act 1994, except where the business, enterprise or activity also involves the handling or sale of food other than dairy products.

Also in this notice:

Fish means any aquatic organism of any species, whether dead or alive, which in the normal course of events, spends part or all of its life in the aquatic environment and is *food* as defined in section 5 of the Act, and includes, but is not limited to:

- (a) the eggs, spat, spawn, seeds, spores, larvae or other offspring of an aquatic organism;
- (b) a shell containing fish or any other part derived from an aquatic organism:
- (c) raw, cooked, dismembered, frozen, preserved, salted or otherwise processed fish; or
- (d) seagrass, seaweed and other aquatic vascular plants, algae, diatoms, euglenoids and any other marine plants

but does not include:

- (e) any aquatic mammal or aquatic bird; or
- (f) a whale as defined in the Whales Protection Act 1988

Meat means the edible part of any animal, including offal, whether manufactured or not, which is intended for human consumption.

Mobile food business means a food business that is conducted in a vehicle but does not include a vehicle used to transport

Pre-packaged food means food packaged for sale, sealed in a closed package that does not require temperature control to maintain the safety and suitability of the food.

Primary food production means the growing, raising, cultivation, picking, harvesting, collecting or catching of food, and includes:

- (a) the transportation or delivery of food on, from or between the premises on which it was grown, raised, cultivated, picked, harvested, collected or caught;
- (b) the packing, treating (for example washing) or storing of food on the premises on which it was grown, raised, cultivated, picked, harvested, collected or caught, or on premises that are associated with the premises on which the food was grown, raised, cultivated, picked, harvested, collected or caught;
- (c) the storage of food in a silo that is not connected with a processing operation and the transportation or delivery of food from, between or to such silos; or
- (d) the sale of livestock at saleyards and the transportation of livestock to and from saleyards.

Shellfish means all edible species of molluscan bivalves or univalves and includes, but is not limited to, oysters, clams, cockles, scallops, pipis, abalone and mussels.
