LIVING MARINE RESOURCES MANAGEMENT ACT 1995

PUBLIC NOTICE - SETTING OF TOTAL ALLOWABLE CATCH (TAC) DETERMINING THE PARTS AND PORTIONS FROM WHICH THE TAC IS TO BE TAKEN FOR THE COMMERCIAL BANDED MORWONG FISHERY (CHEILODACTYLUS SPECTABILIS).

I, BRYAN GREEN, the Minister administering the *Living Marine Resources Management Act 1995*, pursuant to section 94 of that Act, hereby:

- Specify quota periods for the commercial banded morwong fishery as follows:
 - a) From 1 March 2012 to 28 February 2013, inclusive; and
 - b) From 1 March 2013 to 28 February 2014, inclusive; and
 - c) From 1 March 2014 to 28 February 2015, inclusive.
- 2. Set the Total Allowable Catch for each quota period specified for the commercial banded morwong fishery as follows:
 - a) 29,825 fish from 1 March 2012 to 28 February 2013, inclusive; and
 - b) 28,632 fish from 1 March 2013 to 28 February 2014, inclusive: and
 - c) 27,439 fish from 1 March 2013 to 28 February 2015 inclusive.

3. Determine that the part of the commercial banded morwong fishery from which the total allowable catch is to be taken is: the "TAC area" as defined in the *Fisheries (Scalefish) Rules 2004*.

Words and expressions used in this Public Notice have the same meaning as they have in the Living Marine Resources Management Act 1995 and the Fisheries (Scalefish) Rules 2004
