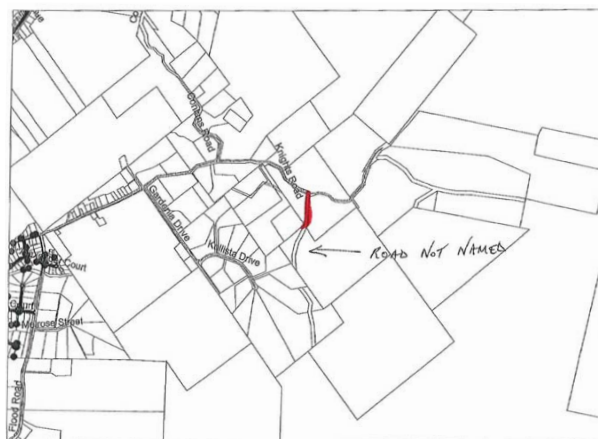
(Section 12 of *The Local Government (Highways) Act 1982*)

WATER AND SEWERAGE INDUSTRY ACT 2008

*Water and Sewerage Industry (Pricing and
Related Matters) Regulations 2011*

Notice of Price Determination of water and sewerage regulated services

The Tasmanian Economic Regulator (the Regulator)—

(a) having undertaken an investigation into the pricing policies of Ben Lomond Water, Cradle Mountain Water and Southern Water in regard to the provision of regulated water and sewerage services on mainland Tasmania; and

(b) in accordance with the *Water and Sewerage Industry Act 2008*,

made Price Determinations under Section 66 of the *Water and Sewerage Industry Act* on 28 May 2012.

The regulated services are water and sewerage services provided by each of these entities.

The Price Determinations commence on 1 July 2012 and end on 30 June 2015 (the first regulatory period).

RULES PUBLICATION ACT 1953

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Evidence Regulations 2012*

These regulations—

- (a) prescribe forms, notices, certificates and affidavits for the purposes of the *Evidence Act 2001*;
- (b) rescind the *Evidence Regulations 2002*.

(2) *Magistrates Court (Administrative Appeals Division) (Fees) Regulations 2012*

These regulations prescribe the fees payable under the *Magistrates Court (Administrative Appeals Division) Act 2001*.

(3) *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment Regulations 2012*

These regulations amend the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010* to extend until 1 July 2013 a temporary exemption from a certain requirement of the *Vehicle and Traffic Act 1999* for providers of community transport.
