2. Determine under Rule 16(1)(a) and 16(1)(b), the specified area of State waters to be open to the commercial scallop fishery for commercial scallop dredging are State waters within the following boundary:
 - i. from latitude 42° 45.0468' S, longitude 148° 7.3797' E; to
 - ii. latitude 42° 45.0468' S, longitude 148° 0.6394' E; to
 - iii. latitude 42° 43.7020' S, longitude 147° 56.5699' E; to
 - iv. latitude 42° 46.4753' S, longitude 147° 53.8132' E; to
 - v. latitude 42° 48.1320' S, longitude 147° 53.8132' E; to
 - vi. latitude 42° 51.8245' S, longitude 147° 57.0292' E; to
 - vii. latitude 42° 52.2348' S, longitude 147° 58.5348' E; to
 - viii. latitude 42° 52.2348' S, longitude 148° 7.3797' E; to
 - ix. latitude 42° 45.0468' S, longitude 148° 7.3797' E.

All coordinates in this notice are expressed by latitude and longitude by reference to the Geocentric Datum of Australia (GDA 94).
3. Specify under Rule 16(1)(c), the amount of scallops that may be taken or possessed from an area determined to be open; as 425 tonnes
