## GENERAL LIQUOR EXEMPTION (No. 1) 2012

*General liquor exemption under the Liquor Licensing Act 1990*

#### PUBLIC NOTICE - DATES OF OPENING AND CLOSING OF THE ROCK LOBSTER FISHERY

##### RULE 11 OF THE FISHERIES (ROCK LOBSTER) RULES 2011

I, ROB GOTT, Director (Marine Resources), pursuant to my delegated power under section 20 (1) of the *Living Marine Resources Management Act 1995*, in accordance with Rule 11 of the *Fisheries (Rock Lobster) Rules 2011*, hereby determine that the public notice - dates of opening and closing of the Rock Lobster Fishery published on 4 July 2012 in *Gazette* Number 21252 is rescinded and:

- (1) The dates of open and closed seasons for that part of the rock lobster fishery comprising of activities by way of fishing for male rock lobster for non commercial purposes are as follows:
  - Open season from 3 November 2012 to 31 August 2013 inclusive;
  - Closed season from 1 September 2013;
- (2) The dates of open and closed seasons for that part of the rock lobster fishery comprising of activities by way of fishing for female rock lobster for non commercial purposes are as follows:
  - Open season from 3 November 2012 to 30 April 2013 inclusive;
  - Closed season from 1 May 2013;
- (3) The dates of open and closed seasons for that part of the rock lobster fishery comprising of activities by way of fishing for male rock lobster for commercial purposes in northern waters are as follows:
  - Closed season from 1 November 2012;
  - Open season from 15 November 2012;
- (4) The dates of open and closed seasons for that part of the rock lobster fishery comprising of activities by way of fishing for male rock lobster for commercial purposes in southern waters are as follows:
  - Closed season from 1 October 2012;
  - Open season from 15 November 2012;
- (5) The dates of open and closed seasons for that part of the rock lobster fishery comprising of activities by way of fishing for female rock lobster for commercial purposes is as follows:
  - Open season from 15 November 2012;
  - Closed season from 1 May 2013;

Where:

“**southern waters**” is defined to mean the area of State waters adjacent to the east, south-east, south, south-west and west coasts of Tasmania bounded in the north on the east coast by the line of latitude at 41° 1’ 0” South and bounded in the north on the west coast by the line of latitude at 42° 11’ 58.3” South; and,

“**northern waters**” is defined to mean the area of State waters adjacent to the east, north-east, north, north-west and west coasts of Tasmania including waters in

Bass Strait bounded in the south on the east coast by the line of latitude at 41° 1’ 0” South and bounded in the south on the west coast by the line of latitude at 42° 11’ 58.3” South.

Words and expressions used in this public notice have the same meaning as in the *Living Marine Resources Management Act 1995* and the *Fisheries (Rock Lobster) Rules 2011*.

### INFORMATION

This notice rescinds the previous public notice (published 4 July 2012, *gazette* no 21252), to correct an error in the one of the line of latitude co-ordinates. This notice sets the open and closed seasons for the rock lobster fishery. The non commercial fishery includes fishing activity undertaken by recreational fishers and Aboriginal persons participating in Aboriginal cultural activities.

#### PUBLIC NOTICE—NOTIFICATION OF CHANGE TO MANAGEMENT PLAN FOR THE TASMANIAN ABALONE FISHERY

I, ROB GOTT, Director (Marine Resources), Department of Primary Industries, Parks, Water and Environment, under section 48A(2) of the *Living Marine Resources Management Act 1995* (the Act) and pursuant to the delegated authority of the Secretary under section 20(2) of that Act hereby give notice that:

1. The management plan for the Tasmanian abalone fishery has been changed pursuant to section 48A(1) of the Act.
2. The change is as follows:

- (a) Rule 3 of the *Fisheries (Abalone) Rules 2009* is changed as follows:

the following words are omitted:

““**quota limit**” means the maximum quantity of abalone authorised to be taken in accordance with a fishing licence (abalone dive) at the start of a fishing trip in a particular part of the fishery;”

to be substituted with the words:

““**quota limit**” means the amount of abalone that may be taken in accordance with a fishing licence (abalone dive) in a part of the fishery at a particular time;”

- (b) Rule 36(3)(a) of the *Fisheries (Abalone) Rules 2009* is changed by omitting “together”.
- (c) Rule 50(9)(a) of the *Fisheries (Abalone) Rules 2009* is changed by inserting the words “all or part of” before the words “the excess abalone”.
- (d) Rule 50(9)(b) of the *Fisheries (Abalone) Rules 2009* is changed by omitting “pay to the Crown, in respect of the excess abalone, an amount equal to –” and substituting “pay to the Crown, in respect of any excess abalone not dealt with under subrule 9(a), an amount equal to –”.
- (e) Rule 50(10) of the *Fisheries (Abalone) Rules 2009* is changed by inserting, after “holder of a fishing licence (abalone dive)” the words “, in respect of any excess abalone not dealt with under subrule (9)”.



- (f) Rule 51 of the *Fisheries (Abalone) Rules 2009* is changed by omitting subrule (2)(a) and substituting the following subrule:

“(a) takes on a fishing trip an amount of abalone that exceeds the licensee’s quota limit by more than 20% but not by more than 30%; or”

*(Explanatory note)*

This order changes the management plan for the abalone fishery by providing:

- (a) for the ability of the holder of a fishing licence (abalone dive) to have quota units assigned to the licensee’s licence while on a commercial fishing trip for abalone;
- (b) that where 2 persons each holding a fishing licence (abalone dive) have formed a diving team for a fishing trip, they may dive from the same vessel or auxiliary boat separately rather than together; and
- (c) that where the amount of abalone taken by the holder of a fishing licence (abalone dive) on a fishing trip exceeds the licensee’s quota limit by more than 20%, the application of the over-catch allowance provisions will depend either on the abalone not exceeding, overall, 30% of the quota limit, or on the weight of excess abalone being less than 20 kg.

Our investment in a world class 'EcoClean' solvent recycling system from Europe has enabled us to recycle all our solvent liquids for reuse, instead of disposing of this material which is traditional industry practice. Waste paper is managed via extraction systems and a compaction unit, capturing and bundling all waste generated during the production cycle which is then collected for recycling, reducing landfill. Vegetable based inks are used where possible on our presses, and green office principles are employed.

Print Applied Technology now adds to these initiatives official certification by the Forest Stewardship Council

(FSC). FSC certification is the "Gold Standard" for eco forestry worldwide, and as a 'Chain of Custody' certificate holder we can now assure our valued customers that selected papers sourced for our operations are from responsibly managed forests.

The use of the highly guarded FSC trademark now also allows our customers to demonstrate their commitment to the growth of responsible forest management. Further to this, we can now share with you the knowledge that areas of natural wealth and endangered wildlife habitat are not being adversely affected as a consequence of our paper sourcing policy.
