#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES (1) Proclamation under section 1B of the *Commercial Arbitration Act 2011*

This proclamation fixes 1 October 2012 as the day on which the provisions of the Commercial Arbitration Act 2011 commence.

(2) Proclamation under section 2 of the Commercial Arbitration (Consequential Amendments) Act 2011

This proclamation fixes 1 October 2012 as the day on which the *Commercial Arbitration (Consequential Amendments) Act 2011* commences.

(3) Proclamation under section 9(1) of the Corrections Act 1997

This proclamation declares that -

- (a) the Hayes Prison Farm ceases to be a prison for the purposes of the Corrections Act 1997; and
- (b) certain land that was part of the former Kilderry Farm Gaol ceases to be a prison for the purposes of the *Corrections Act 1997*.

(4) Inland Fisheries (Recreational Fishing) Amendment Regulations 2012

These regulations amend the *Inland Fisheries (Recreational Fishing) Regulations 2009* to update the reference to regulation 20(a), specified in Column 1 of Schedule 4 to those regulations as an offence in respect of which an infringement notice may be issued, by increasing the maximum daily catch limit, in respect of whitebait licence holders catching whitebait, from one kilogram to 2 kilograms of whitebait.

(5) Justices Amendment Order 2012

This order amends the Justices Order 2004 by -

- (a) inserting an Act as an Act to which section 26(1)(b) of the Justices Act 1959 applies; and
- (b) omitting certain other Acts from the Acts to which section 26(1)(b) of the Justices Act 1959 applies.

#### TASMANIAN GOVERNMENT GAZETTE

#### (6) Wildlife (General) Amendment Regulations 2012

These regulations amend the Wildlife (General) Regulations 2010 by prescribing certain animals as controlled animals for the purposes of the Nature Conservation Act 2002.

(7) Threatened Species Protection Order 2012

This order amends the Threatened Species Protection Act 1995 by -

- (a) adding certain species to, and omitting certain species from, the Schedules of endangered, vulnerable and rare flora and fauna; and
- (b) updating certain common name references in those Schedules.
