PUBLIC NOTICE - DATES OF OPENING AND CLOSING OF THE GIANT CRAB FISHERY

RULE 9 OF THE FISHERIES (GLANT CRAB) RULES 2006

I, ROB GOTT, Director (Marine Resources), pursuant to my delegated power under section 20 (1) of the *Living Marine Resources Management Act 1995*, in accordance with Rule 9(a) of the *Fisheries (Giant Crab) Rules 2006*, hereby determine that:

(1) the part of the commercial giant crab fishery comprising of activities by way of landing male and female giant crab for commercial purposes from north eastern waters will be closed from 25 December 2012

### Where

**"north eastern waters"** is defined to mean the area of State waters adjacent to the north east coast of Tasmania bounded in the north on the east coast by the line of latitude at 40° 39' 18" South and bounded in the south on the east coast by the line of latitude at 41° 01' 00" South.

Words and expressions used in this public notice have the same meaning as in the *Living Marine Resources Management Act* 1995 and the *Fisheries (Giant Crab) Rules 2006.*
