The exemption is granted to the University of Tasmania on the conditions that:

- (a) on at least one occasion in each calendar year of this order being current it arranges with the Office of the Anti-Discrimination Commissioner an opportunity for staff and students who are Aboriginal and/or Torres Strait Islander and those staff supervising students who are Aboriginal and/or Torres Strait Islander at the University of Tasmania to attend an education seminar on relevant rights and obligations under the Anti-Discrimination Act 1988;
- (b) it will report on or before the 12-month anniversary of the granting of this exemption to the Anti-Discrimination Commissioner on education undertaken in compliance with the conditions in (a) above, and on actions taken in reliance on this exemption.

A person may apply to the Anti-Discrimination Tribunal for a review of the Commissioner's decision within 28 days from the date of this notice being published.
