NOTICE - DATES OF CLOSING OF THE COMMERCIAL ABALONE FISHERY IN STATE WATERS OFF THE EAST COAST OF TASMANIA

I, ROBERT GOTT, Director (Marine Resources), acting under Rule 9 of the *Fisheries (Abalone) Rules 2009*, and delegated authority under Section 20(1) of the *Living Marine Resources Management Act 1995*, hereby determine that the dates of the closed season for the commercial abalone fishery for the taking of blacklip abalone (*Haliotis rubra*) for commercial purpose from State waters off the east coast of Tasmania are as follows:

from 1 January 2014 to 31 March 2014 inclusive;

where "State waters off the east coast of Tasmania" is defined to mean: State waters off the east coast of Tasmania bounded in the north by the line of latitude 40° 59' 42" South at Eddystone Point and bounded in the west by the line of longitude 146° 52' 15" East at Whale Head.

The commercial blacklip abalone fishery in State waters off the east coast of Tasmania from Eddystone Point to Whale Head is being closed from 1 January 2014 until 31 March 2014 in the interest of resource sustainability. The closure does not include sub-block 31A.

Call for Submissions

The Department of Health and Human Services is inviting community feedback on the draft *Public Health (Smoke-Free Areas) Regulations 2012*. The regulations outline the areas to be declared smoke-free under Section 67B (1) (m) & (n) of the *Public Health Act 1997*. The proposals aim to reduce environmental tobacco smoke (ETS) and restrict smoking, in certain pedestrian malls and bus malls. The regulations will further protect people from the harmful effects of ETS. They also aim to de-normalise tobacco to children.

Comments regarding these regulations are invited from interested individuals, businesses and organisations. In the interests of open-ness and transparency, submissions will be published on the Department's website. Anonymous submissions will not be accepted.
