This proclamation fixes 1 March 2013 as the day on which the *Vexatious Proceedings Act 2011* commences.

(3) Proclamation under section 2 of the *Water and Sewerage Corporation Act 2012*

This proclamation fixes —

- (a) 1 March 2013 as the day on which the provisions of that Act, except section 44 and Schedule 2, commence; and
- (b) 1 July 2013 as the day on which section 44 and Schedule 2 of that Act commence.
