Appointment of the Honourable Alan Michael Blow OAM to be Lieutenant-Governor of the State of Tasmania.

I. I, the Honourable Peter George Underwood, Companion of the Order of Australia, Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, by this my Commission under the Public Seal of the State of Tasmania hereby appoint you, the said Honourable Alan Michael Blow, Holder of the Medal of the Order of Australia to be during my pleasure, Lieutenant-Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, with all the powers, rights, privileges and advantages to the said Office belonging or appertaining.

II. If the Office of Governor of the said State is vacant, or the Governor of the said State is administering the Government of the Commonwealth of Australia or, not having appointed a Deputy Governor, is for any reason unable to act as Governor, I hereby authorise, empower and command you to exercise and perform all and singular the powers and directions contained in certain Letters Patent under the Public Seal of the said State, bearing date at Hobart the twenty-first day of November 2005, constituting the Office of Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, or in any other Letters Patent adding to, amending, or substituted for the same, and according to such Orders and Instructions as the Governor for the time being of the said State has already received, or as you may hereafter receive from me.

Officers etc, to take notice.

III. I hereby command all and singular the Officers, Ministers, and subjects in the said State and its Dependencies, and all others whom it may concern, to take due notice hereof and to give their ready obedience accordingly.
