#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

##### (1) *Government Prices Oversight (MAIB Premiums) Amendment Order 2013*

This order amends the *Government Prices Oversight (MAIB Premiums) Order 2009* by updating certain definitions and class descriptions of motor vehicles consequent on the commencement of the *Passenger Transport Services Act 2011* and the *Taxi and Luxury Hire Car Industries Amendment Act 2011*.

##### (2) *Nature Conservation (Open Seasons) Amendment Order 2013*

This order amends the *Nature Conservation (Open Seasons) Order 2004* by –

- (a) removing any reference to location in relation to the open season for brown quail with the result that brown quail may be taken from all of the State; and
- (b) by delaying the opening of the open season for brown quail by 2 weeks and providing that the season lasts for 6 weeks instead of 4 weeks.
