#### NOTICE OF THE MAKING OF STATUTORY RULES

IN ACCORDANCE with the provisions of the Rules Publication Act 1953, notice is given of the making of the following statutory rules:—

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

##### (1) Proclamation under section 2 of the *Electricity Reform (Implementation) Act 2013*

This proclamation fixes 1 June 2013 as the day on which the provisions of the *Electricity Reform (Implementation) Act 2013* commence.

##### (2) *Electricity Supply Industry (Pricing and Related Matters) Regulations 2013*

These regulations provide for the regulation of prices set by certain electricity entities and other providers of certain other electrical services, the approval of certain types of contracts, the terms and conditions of certain types of contracts, and the methods by which the prices contained in such contracts are to be fixed.

(3) *National Energy Retail Law (Tasmania) Amendment Regulations 2013*

These regulations amend the *National Energy Retail Law (Tasmania) Regulations 2012* so as to –

- (a) rescind the nomination of Aurora Energy as the local area retailer; and
- (b) rescind a transitional provision that is no longer required; and
- (c) amend certain provisions of the regulations, and certain provisions of the National Energy Retail Rules, that relate to categories of customers that will cease to exist.
