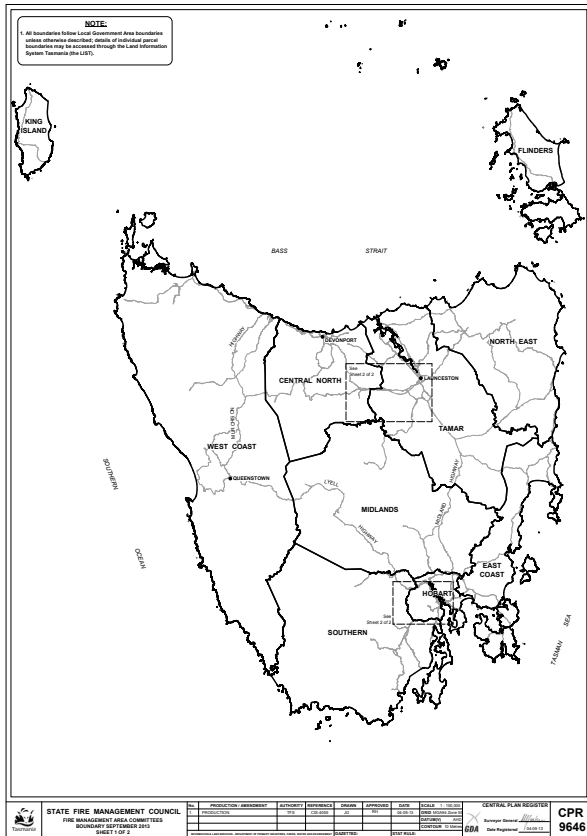
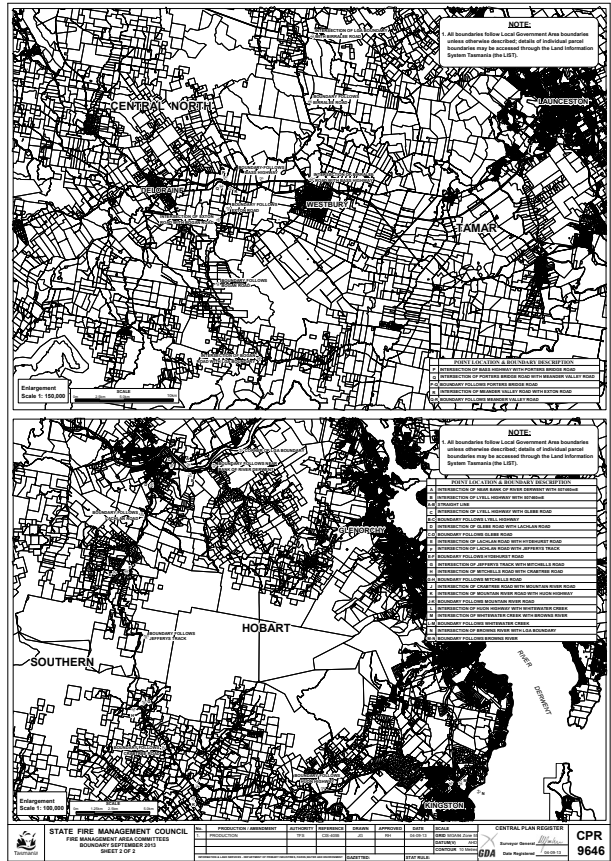

These regulations amend the *Environmental Management and Pollution Control (Environmental Infringement Notices) Regulations 2006* by prescribing offences under the *Plastic Shopping Bags Ban Act 2013* for which environmental infringement notices under the *Environmental Management and Pollution Control Act 1994* may be issued and the penalties applicable to those offences.
