EXEMPTION

WORK HEALTH AND SAFETY REGULATIONS 2012

I, MARTIN EDMUND SHIRLEY, as the Regulator under the *Work Health and Safety Act 2012*, grant a class exemption under Regulation 684 of the *Work Health and Safety Regulations 2012* for the registration of miniature boilers built in accordance with the Code of Practice:

- AMBSC Code – Part 3 – Sub-Miniature Boilers, and
- AMBSC Code – Part 4 – Duplex Steel Boilers.

Exemption decision:

Exemption granted.

Exemption application:

This exemption applies to the class of persons to whom regulations 243, 244, 246 and 276 of the Work Health and Safety Regulations applies. The duties covered by these regulations are –

- application for registration of plant designs;
- application for registration of alterations to plant design;
- application for registration of an item of plant; and
- renewal of registration of an item of plant.

The work or thing to which this exemption applies:

The exemption applies to the registration of miniature boilers built in accordance with the Code of Practice – AMBSC Code Part 3 – Sub-Miniature Boilers and Part 4 – Duplex Steel Boilers.

Commencement of this exemption:

This exemption will apply immediately upon Gazettal.

Regulations to which this exemption applies:

This exemption applies to:

- Regulations 243, 244, 246 and 276 of the Work Health and Safety Regulations;
- Item 1.1 of clause 1 of Part 1 of Schedule 5 of the Work Health and Safety Regulations;
- Item 3.1 of clause 3 of Part 2 of Schedule 5 of the Work Health and Safety Regulations.

Conditions of the exemption:

The following conditions apply to the exemption:

- Design, manufacture and inspections are to be conducted in accordance the Code of Practice in place at that time.
- Inspection and testing must be conducted by inspectors who have the minimum level of competency as prescribed in the Code of Practice.
- The level of inspection and testing must meet the minimum criteria prescribed in the Code of Practice.
- The operators of boilers must receive adequate training to ensure they are competent to operate them safely.
- Any society, club or association that has equipment to which this exemption applies shall maintain a list detailing all boilers to which this exemption applies. This list is to be made available for inspection by officers from WorkSafe Tasmania when requested.

Date and duration of exemption:

This exemption takes effect on notification in the *Gazette*.

This exemption ends two years from notification unless amended or cancelled sooner.

- providing for the filing and serving of notices of objection to bills of cost.
