*LIVING MARINE RESOURCES MANAGEMENT ACT 1995**Fisheries (Shellfish) Rules 2007, Rule 7*

PUBLIC NOTICE – SETTING OF TOTAL ALLOWABLE CATCH (TAC), DETERMINING THE PARTS AND PORTIONS FROM WHICH THE TAC IS TO BE TAKEN FOR THE COMMERCIAL SHELLFISH FISHERY.

I, JEREMY ROCKLIFF, the Minister administering the *Living Marine Resources Management Act 1995*, pursuant to section 94 of that Act and to the *Fisheries (Shellfish) Rules 2007*, Rule 7, for the 2014/2015 quota period of the commercial shellfish fishery commencing 1 September 2014 and finishing 31 August 2015 inclusive, hereby:

1. set the total allowable catch for the commercial shellfish fishery as:
  - 46,800 kilograms of *Venerupis* clams; 13,200 kilograms of *Katelysia* cockles; and 39,800 dozen native oysters;
2. determine that the parts of the commercial shellfish fishery from which the total allowable catch is to be taken are: the Georges Bay South Clam Zone; Georges Bay North Clam Zone; Ansons Bay Cockle Zone; and Georges Bay;

3. determine that the portion of total allowable catch to be taken from each part of the commercial shellfish fishery is as follows:

- Georges Bay South Clam Zone – 0 kilograms of *Venerupis* clams;
- Georges Bay North Clam Zone – 46,800 kilograms of *Venerupis* clams;
- Ansons Bay Cockle Zone – 13,200 kilograms of *Katelysia* cockles; and,
- Georges Bay – 39,800 dozen native oysters.

PUBLIC NOTICE - CLOSED SEASONS FOR STRIPED TRUMPETER, SOUTHERN CALAMARI/GOULD'S SQUID AND BANDED MORWONG

I, ROBERT GOTT, Acting General Manager (Water and Marine Resources), acting as per delegated authority contained in Section 20(1) of the *Living Marine Resources Management Act 1995*, pursuant to Rule 9 of the *Fisheries (Scalefish) Rules 2004*, hereby determine the dates of the closed seasons for those parts of the scalefish fishery that involves the take and possession of:

1. striped trumpeter (*Latris lineata*) by any person in State waters:

from 1 September 2014 to 31 October 2014 (inclusive) and 1 September 2015 to 31 October 2015 (inclusive):

2. all squid species including southern calamari (*Sepioteuthis australis*) by any person in the following State waters:

- Great Oyster Bay (as defined in Schedule 2 of the *Fisheries (Scalefish) Rules 2004*); and

- all east coast Tasmanian waters between an imaginary straight line running due east through Lemon Rock (42°11'44" South [GDA 94]) to the outer limit of State waters and an imaginary straight line running due east from the northern end of Marion Beach (42°46'06" South [GDA 94]) to the outer limit of State waters:

from 15 October 2014 to 14 November 2014 (inclusive) and 15 October 2015 to 14 November 2015 (inclusive); and

- 3 banded morwong (*Cheilodactylus spectabilis*) by any person in all State waters, other than for the possession of banded morwong held on a fishing vessel or in a cauf that have been recorded as 'landed' in Part A of the Commercial Banded Morwong Quota Docket:

from 1 March 2015 to 30 April 2015 (inclusive) and 1 March 2016 to 30 April 2016 (inclusive).

Expressions used in this Public Notice have the same meaning as is in the *Living Marine Resources Management Act 1995* and the *Fisheries (Scalefish) Rules 2004*.

#### Information

This notice closes the fishery for striped trumpeter in all State waters from 1 September 2014 to 31 October and 1 September 2015. This includes all waters from the high water mark to the 200 nautical mile Exclusive Economic Zone limit. No person may take or be in possession of any striped trumpeter on State waters during the closed period, excluding commercial Commonwealth fishers operating under their Commonwealth authority, whom are limited to 150 kg of striped trumpeter per trip. The closure is designed to reduce fishing effort and protect striped trumpeter during the peak spawning period.

No commercial or recreational fisher may take or be in possession of any squid species, including southern calamari and Gould's squid, in Great Oyster Bay and the area described above between Lemon Rock and Marion Beach from 15 October to 14 November 2015 and 15 October to 14 November 2016.

No commercial or recreational fisher may take or be in possession of any banded morwong in State waters from 1 March to 30 April 2015 and 1 March to 30 April 2016.
