Fisheries (Scallop) Rules 2010

NOTICE FOR THE TASMANIAN SCALLOP FISHERY COMPRISING ACTIVITIES BY WAY OF FISHING FOR COMMERCIAL PURPOSES

I, Rob Gott, A/General Manager (Water and Marine Resources Division), Department of Primary Industries, Parks, Water and Environment, pursuant to the delegated authority under Section 20(1) of the *Living Marine Resources Management Act 1995*, in accordance with the *Fisheries (Scallop) Rules 2010*, hereby:

1. Specify under Rule 16(1)(c) of the Rules, the amount of scallops that may be taken or possessed in total from all areas of the commercial scallop fishery determined to be open under the provisions of Rule 16(1)(a) of the Rules is increased to 1,240 tonnes, this amount being inclusive of the 620 tonnes previously specified by Public Notice published in State newspapers on 28 June 2014 and in Special Gazette No. 21 440 on 27 June 2014;
2. Set under Rule 20(2)(b) of the Rules, the maximum percentage of scallop quota units that may be taken in total by the holder of a Fishing Licence (scallop) in the 2014 Open Season is increased to 30%, this amount being inclusive of the 15% previously set by Public Notice published in State newspapers on 28 June 2014 and in Special Gazette No. 21 440 on 27 June 2014.
3. Season dates, specified open areas and size limits remain as determined previously and set by Public Notice published in State newspapers on 28 June 2014 and in Special Gazette No. 21 440 on 27 June 2014.

This Notice specifies the amount of scallops that may be taken by the commercial scallop fishery for waters open for commercial fishing being both the White Rock Scallop Area and the Circular Head Scallop Area with all other waters closed. These arrangements are subject to change.
