LIVING MARINE RESOURCES MANAGEMENT ACT 1995

NOTIFICATION OF ALTERATION TO THE TASMANIAN ROCK LOBSTER FISHERY MANAGEMENT PLAN

I, ROBERT GOTT, Director (Marine Resources) in the Department of Primary Industries, Parks, Water and Environment, pursuant to the delegated authority under Section 20(2) of the *Living Marine Resources Management Act 1995* and in accordance with section 57 of that Act, hereby notify that:

- a. As a result of a review the Minister has accepted a recommendation to alter the management plan for the rock lobster fishery - Fisheries (Rock Lobster) Rules 2011;
- b. The Fisheries (Rock Lobster) Amendment Rules 2015, amend the Fisheries (Rock Lobster) Rules 2011 as they apply to non-commercial fishers by:
 - Reducing the daily bag limit from 3 to 2 rock lobsters in the Eastern Region;
 - Reducing the on water possession limit from 6 to 4 rock lobsters in the Eastern Region;
 - Reducing the boat limit from 15 to 10 rock lobsters irrespective of the number of days fished in the Eastern Region;
 - Redefine the Eastern Region for the purposes of administering possession limits to exclude the land masses of Bruny Island, Flinders Island and Cape Barren Island; and
 - Removing extended trip provisions for boat limits in the Western Region, where a boat limit of 25 rock lobster will apply irrespective of the number of days fished.
- c. The alterations take effect on the date that the notification of making the rules is published in the Tasmanian Government Gazette.

OCCUPATIONAL LICENSING ACT 2015

Occupational Licensing (Plumbing Exemptions) Order 2015

Section 99 - Exemptions

I, DALE WEBSTER Administrator of Occupational Licensing, make the following Order under section 99 of the *Occupational Licensing Act 2005*.

1. Short title

This Order may be cited as the Occupational Licensing (Plumbing Exemptions) Order 2015.

2. Commencement

This Order takes effect on 21 October 2015.

3. REVOCATION

The Occupational Licensing (Plumbing Exemptions) Order 2010, which commenced on the 15 December 2010, is revoked.

4. Purpose of the Order

- (1) The purpose of the Order is to exempt, under section 99 of the Act, certain—
- (a) specified prescribed plumbing work;
- (b) persons of specified occupations and classes of prescribed plumbing work; and
- (c) specified persons -

from the provisions of the Act.

(2) The exemptions may be made with or without conditions.

5. Interpretation

In this Order, unless the context otherwise requires –

- "Act" means the Occupational Licensing Act 2005;
- "Administrator" means the person appointed as the Administrator of Occupational Licensing under section 10 of the Act;
- **"plumbing work"** has the meaning prescribed by regulation 3 of the Regulations;
- "plumber practitioner" has the meaning given by regulation 3 of the Regulations;
- "plumber practitioner (certifier)" has the meaning given by regulation 3 of the Regulations;
- "Regulations" means the Occupational Licensing (Plumbing Work) Regulations 2010;

6. Application of Acts Interpretation Act 1931

The Acts Interpretation Act 1931 applies to this Order.

7. Exemption of persons to undertake certain prescribed plumbing work

- (1) In this Clause -
- "minor tap repairs" do not include the repair of any thermostatic mixing valve, tempering valve, backflow prevention valve, or a non-return valve on a hot water storage heater.
- (2) In accordance with section 99(1)(b) of the Act, I exempt from the requirement to be licensed under section 22(1) of the Act, persons who undertake the following prescribed plumbing work—
- (a) the repair or replacement of tap washers and other minor tap repairs by the owner of a dwelling; or
- (b) the replacement of a shower head in a dwelling, with a shower head with a minimum 3 star water rating under the Water Efficiency Labeling Standards (WELS) Scheme.
- (3) Despite sub-clause (2) above, persons who carry out plumbing work under this exemption must, nevertheless, undertake the work in accordance with the standards for plumbing work prescribed by the *Building Act 2000*.

8. Exemption of persons of a specified occupation and class

In accordance with section 99(1)(a) of the Act, I exempt from the provisions of the Act sheetmetal work undertaken by sheetmetal tradespersons, where the work is carried out in connection with the manufacture, installation, maintenance or repair of ventilation or air conditioning plant or equipment.

9. Exemption of specified persons

- (1) In accordance with section 99(1)(a) of the Act, I exempt persons assisting plumber practitioners and plumber practitioner (certifiers), who perform work in association with prescribed plumbing work, from the provisions of section 22(1) the Act.
- (2) This exemption applies only if the persons assisting the plumber practitioners and plumber practitioner (certifiers) are supervised at a level commensurate with their knowledge, skills and experience in accordance with the Occupational Licensing (Supervision of Prescribed Work) Code of Practice 2010, as amended from time to time.

10. Exemption of persons to undertake the servicing and maintenance of Domestic On-Site Waste Water Management Systems

- (1) In accordance with section 99(1)(a) of the Act, I exempt persons undertaking the servicing and maintenance of Domestic On-Site Waste Water Management Systems from the requirement to be licensed under section 22(1) of the Act.
- (2) This exemption only applies if persons performing the servicing and maintenance are -
 - (a) working under the control and management of a licensed plumber contractor, whose nominated manager holds a Plumber Practitioner (Certifier) Drainage class licence with the Domestic On-Site Waste Water Management Systems Maintenance endorsement; and
 - (b) have successfully completed the manufacturer's or Administrator's training requirements for the servicing and maintenance of those systems; and
 - (c) undertakes the work in accordance with the codes of practice under the Act and standards for plumbing work prescribed by the *Building Act 2000*.
- (3) The exemption does not apply to persons engaged in the installing of Domestic On-Site Waste Water Management Systems.
- (4) The exemption of persons to undertake the servicing and maintenance of Domestic On-Site Waste Water Management Systems expires on 30 April 2016.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Fisheries (Rock Lobster) Amendment Rules 2015

These rules amend the Fisheries (Rock Lobster) Rules 2011 by -

- (a) setting a lower daily bag limit and lower possession limits for the non-commercial fishery in the eastern region; and
- (b) setting new boat limits for the non-commercial fishery in the eastern and western regions, being boat limits that are generally lower and will apply regardless of the duration of a fishing trip; and
- (c) adjusting the definition of 'eastern region'.
 - (2) Proclamation under sections 9A and 52A of the Roads and Jetties Act 1935

This proclamation revokes certain proclamations relating to the Lyell Highway, the new Cradle Mountain Developmental Road and the Tasman Highway.

(3) Proclamation under section 2 of the *Victims of Crime Assistance Amendment (Funeral Expenses) Act 2015*This proclamation fixes 1 November 2015 as the day on which the *Victims of Crime Assistance Amendment (Funeral Expenses) Act 2015* commences.

(4) Victims of Crime Assistance Amendment Regulations 2015

These regulations amend the Victims of Crime Assistance Regulations 2010 -

- (a) by prescribing \$10 000 as the maximum total amount that may be awarded under section 4(1A) of the *Victims of Crime Assistance Act 1976*; and
- (b) so that an application for an award for funeral expenses in respect of the death of a primary victim includes details of the funeral expenses actually and reasonably incurred, or reasonably likely to be incurred, by a person in relation to that death.

(5) Public Health (Tobacco Advertisements) Revocation Order 2015

This order revokes the Public Health (Tobacco Advertisements) Order 2012.
