#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

#### (1) Water Management (Division 3 Declared Works) Order 2015

This order prescribes classes of dam works that require a Division 3 permit under the Water Management Act 1999.

#### (2) Water Management (Division 4 Permit Conditions) Order 2015

This order determines that it is a condition of a Division 4 permit that the dam works to which the permit relates must be carried out in accordance with the *Division 4 Permit Dam Works Code 2015* issued on 25 November 2015.

(3) Civil Process (Table of Fees for Execution) Amendment Rules 2015

These Rules of Court amend the *Civil Process (Table of Fees for Execution) Rules 1991* to prescribe the fee payable to the Sheriff of the Supreme Court for a levy or seizure by the Sheriff in respect of a debt or in respect of a writ of execution.

(4) Supreme Court Amendment Rules 2015

These Rules of Court amend the Supreme Court Rules 2000 by -

- (a) updating the procedures relating to proceedings in arbitration under the *Commercial Arbitration Act 2011*, and the *International Arbitration Act 1974* of the Commonwealth, to be consistent with other jurisdictions; and
- (b) prescribing procedures to be followed in proceedings relating to unexplained wealth under Part 9 of the Crime (Confiscation of Profits) Act 1993; and

(c) providing the Sheriff with a discretion in relation to the execution of certain writs; and

(d) updating certain provisions relating to the procedures of the Supreme Court.
