EXEMPTION/S GRANTED

THE following application for exemption from the provisions of the Anti-Discrimination Act 1998 (Tas) (the Act) has been granted:

1. Launceston Women's Shelter Inc (Magnolia Place LWS) – (15/02/001) – Application for exemption granted under section 57 of the Act for the period commencing 5 February 2015 and ending on 1 October 2017.

This exemption has been granted to permit Launceston Women's Shelter Inc to recruit and employ women only to the identified position of Administration Assistant on the basis that this is for the purpose of operating a shelter for women and children escaping domestic/family violence and /or who are homeless to provide a secure, safe and supportive women-only space.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Public Health (Tobacco Seller's Licence) Amendment Regulations 2015*

These regulations amend the *Public Health (Tobacco Seller's Licence) Regulations 2009* by –

- (a) increasing the fees payable for the application, or renewal, of a tobacco seller's licence; and
- (b) removing certain spent provisions.

(2) *Road Amendment (Overtaking and Passing Bicycles) Rules 2015*

These rules amend the *Road Rules 2009* by –

- (a) providing an exemption, from certain road rules, for motorists who are overtaking or passing the rider of a bicycle; and
- (b) allowing a driver, in certain circumstances, to move from one marked lane to another marked lane by crossing a continuous dividing line.
