## Living Marine Resources

### LIVING MARINE RESOURCES MANAGEMENT ACT 1995

#### PUBLIC NOTICE

SETTING OF TOTAL ALLOWABLE CATCH (TAC), DETERMINING THE PARTS AND PORTIONS FROM WHICH THE TAC IS TO BE TAKEN FOR THE COMMERCIAL BANDED MORWONG FISHERY (*Cheilodactylus spectabilis*).

I, JEREMY ROCKCLIFF, the Minister administering the *Living Marine Resources Management Act 1995*, pursuant to section 94 of that Act, hereby:

1. Set the Total Allowable Catch for the commercial banded morwong fishery for the quota period 1 March 2015 to 29 February 2016 inclusive as 27,439 fish; and,
2. Determine that the part of the commercial banded morwong fishery from which the total allowable catch is to be taken is: the "TAC area" as defined in the *Fisheries (Scalefish) Rules 2004*.

Words and expressions used in this Public Notice have the same meaning as they have in the *Living Marine Resources Management Act 1995* and the *Fisheries (Scalefish) Rules 2004*.
