Tasmanian Health Organisations Act

TASMANIAN HEALTH ORGANISATIONS ACT 2011

(Section 81 and Schedule 6)

Notice of Transfer of Specified Contracts, Property and Liabilities of the Crown to
Tasmanian Health Service

I, **The Honourable Michael Darrel Joseph Ferguson MP**, Minister for Health, acting pursuant to section 81 and clause 4 of Schedule 6 of the *Tasmanian Health Organisations Act 2011* (the **Act**), transfer the contracts, property and liabilities of the Crown specified in the Schedule to the Tasmanian Health Service with effect on 1 July 2015 (the Transfer Day).

Schedule

1. Contracts

- (a) All contracts, relating solely to the Transferring Services made before 11.59pm on 30 June 2015 between the Crown and one or more other persons pursuant to which one or more of the other persons is required to supply any goods, substances or services to the Crown on or after the Transfer Day.
- (b) All contracts made before 11.59pm on 30 June 2015 between the Crown and one or more other persons pursuant to which the Crown, as represented by, or acting through, the Transferring Services at the time the contract was made, is required to supply any goods, substances or services to any person on or after the Transfer Day.

2. Property

- a. Cash and deposits held by the Crown as at 11.59pm on 30 June 2015 in special purpose trust accounts solely relating to the Transferring Services.
- b. Amounts prepaid by the Crown as at 11.59pm on 30 June 2015 for goods and services (other than inventories) solely relating to the Transferring Services.
- c. Inventories held by the Crown as at 11.59pm on 30 June 2015 solely for the Transferring Services.
- d. All plant and equipment owned by the Crown held, or used by or for the operation of, the Transferring Services as at 11.59pm on 30 June 2015 but excluding any Excluded Property.
- e. Accounts receivable (accrued but whether or not invoiced) by the Crown as at 11.59pm on 30 June 2015 solely relating to the Transferring Services.
- f. Doubtful debts held by the Crown as at 11.59pm on 30 June 2015 solely relating to the Transferring Services.

3. Liabilities

- a. A liability of the Crown relating to the Transferring Services in respect of any amount prepaid by any person to the Crown for the delivery of any goods or services to that person by the Crown on or after the Transfer Day.
- b. A liability (accrued but whether or not invoiced) of the Crown relating to the the Transferring Services in respect of any trade creditors and accruals as at 11.59pm on 30 June 2015.
- c. Accrued salaries relating to the Transferring Services as at 11.59pm on 30 June 2015.

4. Interpretation

In this notice:

Department means the Department of Health and Human Services.

Excluded Property means:

- (a) any fixtures to land or buildings; and
- (b) information and communication technology plant, equipment and software used to operate information technology systems.

Transferring Services means the Department of Health and Human Services' unit known as Cancer Screening and Control Services as structured as at 11.59pm on 30 June 2015.

Unless a contrary intention is apparent, words or phrases or terms defined in the Act have meanings given to them in the Act.

(1) *Local Government (General) Regulations 2015*

- (a) electoral advertising and elections by councillors of mayors and deputy mayors; and
- (b) the hearing and determination of election disputes and certain procedures related to determining elections; and
- (c) codes of conduct for councillors and procedures relating to the hearing by a Code of Conduct Panel and a Standards Panel of complaints and appeals; and
- (d) tendering and contracting; and
- (e) allowances and expenses of councillors; and
- (f) other miscellaneous matters under the

These regulations prescribe meeting procedures for councils and council committees.
