(1) Property Agents and Land Transactions Regulations 2016

These regulations -

(a) prescribe –

- (i) requirements for the keeping, maintenance, auditing and inspection of trust account records; and
- (ii) requirements for the investment of trust money; and
- (iii) accounting and reporting requirements for the Property Agents Trust; and
- (iv) qualifications for certain persons; and
- (v) fees payable under the Property Agents and Land Transactions Act 2005; and
- (b) set out the Code of Conduct for property agents; and
- (c) are made consequentially on the repeal of the *Property Agents and Land Transactions Regulations 2006* under section 11 of the *Subordinate Legislation Act 1992*.
