Legislative Council Electoral Boundaries

LEGISLATIVE COUNCIL ELECTORAL BOUNDARIES ACT 1995

I, THE HONOURABLE PROFESSOR KATE WARNER, Member of the Order of Australia, Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, acting under the provisions of sections 4, 6 and 7 of the *Legislative Council Electoral Boundaries Act 1995*, hereby appoint the members and alternate members of the Redistribution Tribunal, approve the fees and allowances to be paid to the Tribunal, specify the purposes for which the Tribunal are appointed and specify the period which may be required for the proper performance of the functions of the Tribunal under the Act.

THE TRIBUNAL

I appoint as members of the Tribunal:

ANDREW ROBIN DENIS HAWKEY, the Electoral Commissioner, as the member required by section 6(1) of the Act; and MICHAEL STEPHEN GIUDICI, the Surveyor-General, as the member required by section 6(1) of the Act; and

LISA MICHELE WARDLAW-KELLY, who has been nominated by the Australian Statistician, as the member required by section 6(1) of the Act; and

HOWARD MICHAEL BLAKE, the chairperson of the Electoral Commission, as the member required by section 6(1)(a) of the Act; and

KAREN ELIZABETH FROST, the member of the Electoral Commission who is not the chairperson of that Commission or the Electoral Commissioner, as the member of the Tribunal required by section 6(1)(b) of the Act.

I appoint in pursuance of section 7(1) of the Act as the alternate members of the Tribunal:

JOHAN VANDERNIET, as alternate member for Michael Giudici; and

ELIZABETH HELEN O'TOOLE, who has been nominated by the Australian Statistician, as the alternate member for Lisa Michele Wardlaw-Kelly.

The Tribunal is appointed for the purpose of performing the functions of the Tribunal under Divisions 4 and 5 of Part 2 of the Act including:

- considering objections to the initial redistribution proposal made by the Redistribution Committee, inquiring into objections, making any further redistribution proposals, considering and inquiring into further objections, and determining the names and boundaries of the electoral divisions into which the State is to distributed; and
- the making of an initial transition proposal, considering comments, suggestions and objections, inquiring into matters raised in the comments, suggestions and objections and making a determination of the transition arrangements to implement the redistribution of the State in respect of the Legislative Council.

I approve in pursuance of section 8 of the Act, the fees and allowances to be paid to eligible members of the Tribunal as set out in the attached Schedule.

I specify the period which is required for the proper performance of the functions of the Tribunal under the Act as being from the date of this Notice until Friday 30 June 2017.

- 1. The Chairperson of the Redistribution Tribunal is entitled to be paid a fee per meeting or sitting day of \$337;
- 2. The member of the Tribunal appointed under section 6(1)(b) is entitled to be paid a fee per meeting or sitting day of \$225;
- 3. When travelling on official business each member or alternate member of the Redistribution Tribunal is entitled to the following travelling expenses:
 - (a) If required to be away from home overnight Tasmanian Public Service rates
 - (b) Travelling expenses per kilometre -\$0.72
