# Residential Building Work Contracts and Dispute Resolution

RESIDENTIAL BUILDING WORK CONTRACTS AND DISPUTE RESOLUTION ACT 2016

RESIDENTIAL BUILDING CONSUMER GUIDE

Pursuant to section 81(1) of the *Residential Building Work* Contracts and Dispute Resolution Act 2016 (the Act), and section 11 of Acts Interpretation Act 1931, the 'Residential Building Consumer Guide' is approved.

The 'Residential Building Consumer Guide' has been developed by Consumer, Building and Occupational Services (CBOS) to assist home owners undertaking residential building work for a contract price of \$20,000 or more. It is designed to help owners avoid disputes and common pitfalls in relation to residential building work contracts, by explaining their rights and obligations under the Act.

Building contractors must provide a copy of the 'Residential Building Consumer Guide' to the owner before a residential building work contract is signed, in accordance with section 39 of the Act. Owners and building contractors must sign and retain the signed acknowledgement page at the back of the 21 December 2016

Guide, as part of the contract records.

The 'Residential Building Consumer Guide' takes effect on 1 January 2017, and supersedes all previous consumer guides in relation to residential building work.



#### Revocation of Restriction Relating to Prescribed Matter in a Control Area

Plant Quarantine Act 1997

Section 33

I, Andrew Christian Bishop, delegate to the Secretary of the Department of Primary Industries, Parks, Water and Environment under section 7 of the *Plant Quarantine Act 1997* (the Act), do hereby revoke pursuant to section 33(3) of the Act, the restrictions and prohibitions imposed on 2 April 2015 and specified in Part B of this Notice, in respect to the control areas or parts thereof described in Part A of this Notice, being prohibitions and restrictions that are in addition to those already applying in respect to the control areas.

#### Part A - control areas or parts of control areas to which the revoked restrictions and prohibitions in Part B apply

The entirety of all control areas currently extant within Tasmania (see Annexure 1).

#### Part B - revoked restrictions and prohibitions applying to control areas or parts of control areas referred to in Part A

### 1. Interpretation

For the purposes of this Notice,

'the Act' means the Plant Quarantine Act 1997

supply includes the following:

(a) deliver, sell, trade, give or distribute, whether for valuable consideration or not;

- (b) offer or agree to supply;
- (c) cause or permit to supply;
- (d) hold in possession for the purpose of supply;
- (e) propagate, harvest, or pack for the purpose of supply;

all other words and expressions have the same meaning as they have in the Act.

#### 2. Restriction on supply of prescribed matter within control area

A person who is not an inspector must not supply any plant or plant product of *Ugni molinae* (common name: Chilean guava or TazziberryTM) into, within or out of the control area except in accordance with the direction of an inspector.






# Annexure 1 (page 1): Extant Control Areas to which this Revocation Notice Applies

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Admission to Courts (Lower Courts) Regulations 2016

These regulations -

(a) provide, for the purposes of the Admission to Courts Act 1916, for -

21 December 2016

- (i) the admission to, the refusal of admission to, or the removal of persons from, lower courts in certain circumstances; and
- (ii) the possession of certain objects to be prohibited, and the seizure of those objects, in certain circumstances; and
- (iii) the power to arrest persons, and to search persons and objects, in certain circumstances; and
- (iv) other powers and duties of authorized officers under that Act; and
- (v) the appointment of appointed persons and other miscellaneous matters; and
- (b) are made consequentially on the repeal of the *Admission to Courts (Lower Courts) Regulations 2006* under section 11 of the *Subordinate Legislation Act 1992*.

(2) Admission to Courts (Supreme Court) Regulations 2016

These regulations -

- (a) provide, in relation to the Admission to Courts Act 1916, for -
  - (i) the admission to, the refusal of admission to, or the removal of persons from, the Supreme Court of Tasmania in certain circumstances; and
  - (ii) the possession of certain objects to be prohibited, and the seizure of those objects, in certain circumstances; and
  - (iii) the power to arrest persons, and to search persons and objects, in certain circumstances; and
  - (iv) other powers of authorized officers; and
  - (v) the appointment of appointed persons and other miscellaneous matters; and
- (b) are made consequentially on the repeal of the Admission to Courts (Supreme Court) Regulations 2006 under section 11 of the Subordinate Legislation Act 1992.

#### (3) Adoption Regulations 2016

These regulations -

- (a) make provision in relation to
  - (i) applications by organisations for approval as adoption agencies, the appointment of the staff of adoption agencies and the facilities and services to be provided by adoption agencies; and
  - (ii) applications by persons for approval as adoptive parents and the requirements such persons are to meet; and
  - (iii) the forms associated with the adoption process; and
  - (iv) the placement of children with a view to adoption; and
  - (v) the classes of children who are eligible for financial and other assistance in connection with an adoption; and
  - (vi) the fees payable under the Act; and
- (b) are made consequentially on the repeal of the *Adoption Regulations 2006* under section 11 of the *Subordinate Legislation Act 1992*.
- (4) Proclamation under section 2 of the *Building Act 2016*

This proclamation fixes 1 January 2017 as the day on which the Building Act 2016 commences.

#### (5) Building Regulations 2016

These regulations make provision for the following matters relating to building work, plumbing work and demolition work under the *Building Act 2016*:

- (a) matters in relation to the performance of building work, plumbing work and demolition work;
- (b) the power of the Director of Building Control to make guidelines and determinations in respect of certain matters;
- (c) maintenance requirements under that Act;
- (d) occupancy requirements under that Act;
- (e) other miscellaneous matters.
- (6) Local Government (General) Amendment Regulations (No. 2) 2016

These regulations amend the Local Government (General) Regulations 2015 by updating certain legislative references consequent on the commencement of the Building Act 2016.

(7) Occupational Licensing (Building Services Work) Regulations 2016

These regulations provide, for the purposes of the Occupational Licensing Act 2005 -

- (a) in relation to building services work
  - (i) the prescribed work that is building services work for the purposes of that Act; and
  - (ii) the work that is excluded from being prescribed work that is building services work for the purposes of that Act; and
  - (iii) the requirement to notify the Administrator of changes to certain details in relation to a building services licence; and
- (b) the criteria to be met by a person in order to be eligible to hold an owner builder permit; and
- (c) in relation to both building services providers and owner builders –

- (i) licensing and other fees; and
- (ii) infringement notice offences and other penalties.
- (8) Poisons Amendment (Miscellaneous) Regulations 2016

These regulations amend the Poisons Regulations 2008 by -

- amending the list of narcotic substances for which a prescription may only be issued on the authority of the Secretary; (a) and
  - amending the definition of "PBS medication chart"; and (b)
  - providing for the administration of topical local anaesthetics by speech pathologists; and (c)
  - (d) providing for the administration of certain substances by Aboriginal health workers; and
- providing for disability service workers to assist certain people in the self-administration of narcotic substances; and (e)
- making various other minor amendments. (f)

#### (9) Public Health (Tobacco Seller's Licence) Amendment Regulations 2016

These regulations amend the Public Health (Tobacco Seller's Licence) Regulations 2009 by increasing the fees payable for the application, or renewal, of a tobacco seller's licence.

#### (10)Radiation Protection Amendment Regulations 2016

These regulations amend the Radiation Protection Regulations 2016 to update a legislative reference consequent on the commencement of the Building Act 2016.

Radiation Protection Amendment (Fees) Regulations 2016 (11)

These regulations amend the Radiation Protection Regulations 2016 by increasing certain fees prescribed under the Radiation Protection Act 2005.

Proclamation under section 2 of the Residential Building Work Contracts and Dispute Resolution Act 2016 (12)

This proclamation fixes 1 January 2017 as the day on which the Residential Building Work Contracts and Dispute Resolution Act 2016 commences.

#### (13)Work Health and Safety Amendment Regulations 2016

These regulations amend the Work Health and Safety Regulations 2012 by -

- delaying the commencement of certain provisions of those regulations, relating to diving work, until 1 January 2019; (a) and
- updating the labelling requirements for certain hazardous chemicals in certain circumstances. (b)
- (14)Youth Justice Amendment Regulations 2016

These regulations amend the Youth Justice Regulations 2009 to -

- prescribe the following persons as prescribed officers for the purposes of section 135A(1) of the Youth Justice Act (a) 1997
  - (i) the Commissioner for Children and Young People appointed and holding office under the Commissioner for Children and Young People Act 2016;
  - (ii) the Custodial Inspector appointed under section 5 of the Custodial Inspector Act 2016; and
- prescribe the following Acts as prescribed Acts for the purposes of section 135A(2)(a) and section 135A(2)(b) of the *Youth Justice Act 1997*: (b)
  - (i) the Commissioner for Children and Young People Act 2016;
  - (ii) the Custodial Inspector Act 2016.
- Nature Conservation (Open Seasons) Amendment (Deer) Order 2016 (15)

This order amends the Nature Conservation (Open Seasons) Order 2004 by altering the dates of the open seasons for adult male European fallow deer and antlerless European fallow deer.
