where "State waters off Albatross Island" is defined to mean: the area of State waters off the north-west coast of Hunter Island enclosed in the east by the line of longitude 144° 40' 42.23" East, in the west by the line of longitude 144° 38' 03.03" East, in the north by the line of latitude 40° 21' 32.63" South, and in the south by the line of latitude 40° 23' 35.95" South.

The holder of a fishing licence (abalone dive) can not on a fishing trip enter the water by swimming or diving in both an open and a closed part of the fishery regarding the same species.
