# **Anti-Discrimination**

## ANTI-DISCRIMINATION ACT 1998

EQUAL OPPORTUNITY TASMANIA

#### EXEMPTION/S GRANTED

The following application for exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

1. Cancer Council Tasmania – 16/06/011 – Application for an exemption granted under section 57 of the Act for a period of three years.

This exemption has been granted to permit Cancer Council Tasmania to develop and deliver a culturally appropriate employment strategy in relation to Aboriginal and Torres Strait Islanders in Tasmania, including the recruitment and employment of an Aboriginal Quitline Counsellor on the basis that it is consistent with:

- (a) section 25 of the Act, which provides an exception for discrimination 'if it is for the purpose of carrying out a scheme for the benefit of a group which is disadvantaged or has a special need because of a prescribed attribute'; and
- (b) section 26 of the Act, which provides an exception for discrimination 'in any program, plan or arrangement designed to promote equal opportunity for a group which is disadvantaged or has a special need because of a prescribed attribute'; and
- (c) section 41 of the Act, which provides an exception for discrimination 'on the ground of race in relation to employment if the discrimination is based on a genuine occupational qualification or requirement in relation to a particular position'.

Granted on the 15th day of June 2016.

The exemption is for the period of three (3) years subject to the fulfilment of the conditions that Cancer Council Tasmania:

- a) report on or before 15 June 2017 to the Anti-Discrimination Commissioner on actions taken in reliance on this exemption;
- b) on at least one occasion in the 12 months immediately after this order is made, organise and promote community education for its staff, members, officers, clients and volunteers of Cancer Council Tasmania through Equal Opportunity Tasmania's community education program to increase awareness of rights and obligations under the *Anti-Discrimination Act 1998* (Tas).

A person may apply to the Anti-Discrimination Tribunal for a review of the Commissioner's decision within 28 days from the date of this notice being published

# GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the *Commissioner for Children and Young People Act 2016*This proclamation fixes 1 July 2016 as the day on which the *Commissioner for Children and Young People Act 2016* commences.

(2) Coroners (Fees, Expenses and Allowances) Regulations 2016

These regulations -

- (a) prescribe the fees, expenses and allowances that are payable under the Coroners Act 1995; and
- (b) are made consequentially on the repeal of the *Coroners (Fees, Expenses and Allowances) Regulations 2006* under section 11 of the *Subordinate Legislation Act 1992*.
  - (3) Proclamation under section 7 of the Corporations (Commonwealth Powers) Act 2001

This proclamation extends, by a further 5 years, the referral to the Commonwealth of the State's power to regulate corporations as referred under the *Corporations (Commonwealth Powers) Act 2001*.

#### (4) Inland Fisheries (Recreational Fishing) Amendment Regulations 2016

These regulations amend the Inland Fisheries (Recreational Fishing) Regulations 2009 by -

- (a) adding Lake Leake, Pioneer Lake, South Riana Dam and Talbots Lagoon to the list of waters from which the taking of salmon less than 300 millimetres long is prohibited; and
- (b) adding Big Waterhouse Lake, Lake Leake, Little Waterhouse Lake, Pioneer Lake, South Riana Dam and Talbots Lagoon to the list of waters from which the taking of more than 2 salmon that are equal to or more than 500 millimetres long is prohibited and clarifying that this is a daily bag limit; and
- (c) adding Talbots Lagoon to the list of waters from which the taking of fish from mechanically propelled boats is prohibited;
- (d) adding Lake Crescent to the list of waters from which fish must not be taken except by means of a lure, which consequentially also makes that lake one of the places at which the possession of bait and non-artificial lures is prohibited; and
- (e) adding Pioneer Lake, South Esk River, South Riana Dam and Talbots Lagoon to the list of waters for which there is a daily bag limit for the taking of salmon, and setting the corresponding daily bag limits; and
- (f) correcting some place names, adjusting the schedule of infringement notice offences and effecting minor statute law revision.

#### (5) Proclamation under section 2 of the Living Marine Resources Management Amendment Act 2015

This proclamation fixes 1 July 2016 as the day on which the provisions of the *Living Marine Resources Management Amendment Act 2015* commence.

#### (6) Mineral Resources Regulations 2016

These regulations -

- (a) provide for various matters under the *Mineral Resources Development Act 1995* including the payment of royalties, fees and rents; and
- (b) are made consequentially on the repeal of the *Mineral Resources Regulations 2006* under section 11 of the *Subordinate Legislation Act 1992*.

## (7) Wildlife (General) Amendment (Browsing Animal Management) Regulations 2016

These regulations amend the *Wildlife (General) Regulations 2010* to specify that the holder of a crop protection permit may, if authorised by a condition of that permit, allow a person other than the holder of the permit to take wildlife as specified in the permit.

(8) Proclamation under section 7 of the Roads and Jetties Act 1935

This proclamation declares -

- (a) Elephant Pass Main Road to be a subsidiary road that is classified as a main road; and
- (b) Tarkine Tourist Road to be a subsidiary road that is classified as a tourist road.

# (9) State Service (Restructuring) Order 2016

This order amalgamates the Poppy Advisory and Control Board with the epartment of Primary Industries, Parks, Water and Environment.

# Parliamentary Salaries, Superannuation and Allowances

# **Notice of Determination**

In February 2016 a report, including a determination by the Full Bench of the Tasmanian Industrial Commission, was issued into Salary and Allowances for Members of the Tasmanian Parliament.

Pursuant to Section 31(1), Part 3 of the Parliamentary Salaries, Superannuation and Allowances Act 2012 a Notice of determination is published as follows:

This Determination is made in accordance with section 3D(1)(d) of the *Parliamentary Salaries, Superannuation* and *Allowances Act 2012* (the 2012 Act).

As the Commission we determine the following:

## 1 Basic Salary

- 1.1 Basic Salary (refer clause 5 of Part 1 of Schedule 1 to the 2012 Act)
  - (1) From 1 July 2016 to 30 June 2017, the amount of the basic salary to be paid to each member of Parliament is to be \$133 560 pa.
  - (2) From 1 July 2017 to 30 June 2018, the amount of the basic salary to be paid to each member of Parliament is to be \$133 560 pa plus either:
    - (a) an amount equal to \$133 560 multiplied by the increase in the Wage Price Index, Ordinary Time Hourly Rates of Pay Excluding Bonuses; Tasmania, Private and Public; all Industries (ABS Catalogue 6345.0) for the twelve months preceding the December 2016 quarter, or
    - (b) \$0 should that Index not increase in that period.

## 2 Additional Salary

- 2.1 Additional Salary (refer clause 3 of Part 2 of Schedule 1 to the 2012 Act)
  - (1) From 1 July 2016 to 30 June 2018, the amount of the additional salary to be paid to the Premier, Deputy Premier, Ministers of the Crown, Secretary to Cabinet and Certain Officers of the Parliament is the percentage of basic salary specified opposite the office in the following table (Table A).

# 2.2 Additional Salary (refer clause 5 of Part 2 of Schedule 1 to the 2012 Act)

(1) From 1 July 2016 to 30 June 2018, the amount of the additional salary to be paid to the holder of an office specified in Table 2 of Part 2 of Schedule 1 to the 2012 Act is the percentage of basic salary specified opposite the office in the following table (Table B).

## 3 Allowances<sup>3</sup>

## 3.1 Motor Vehicle Allowance

- (1) From 1 July 2016 to 30 June 2017, the amount of the Motor Vehicle Allowance is \$15 613 pa.
- (2) From 1 July 2017 to 30 June 2018 the amount of the Motor Vehicle Allowance is to be \$15 613 pa plus either:
  - (a) an amount equal to \$15 613 multiplied by the increase in the Consumer Price Index, Hobart, All Groups (ABS Catalogue 6401.0) for the twelve months preceding the December 2016 quarter, or
  - (b) \$0 should that Index not increase in that period.

## 3.2 Electorate Allowance

(1) From 1 July 2016 to 30 June 2017, the amount of the Electorate Allowance to be paid to a member of Parliament is the amount in the following table (Table C) specified opposite the electorate to which that member is elected.

- (2) From 1 July 2017 to 30 June 2018, the amount of the Electorate Allowance to be paid to a member of Parliament is the amount in Table C specified opposite the electorate to which that member is elected plus either:
  - (a) an amount equal to that amount multiplied by the increase in the Consumer Price Index, Hobart, All Groups (ABS Catalogue 6401.0) for the twelve months preceding the December 2016 quarter, or
  - (b) \$0 should that Index not increase in that period.

## 3.3 Committee Sitting Fees

From 1 July 2016 to 30 June 2018, there is payable to the Chair of a Committee, for each day on which the Chair attends a summoned meeting of that Committee at which a quorum is present, a sitting fee calculated on a daily basis, irrespective of the number of meetings, at the rate of 0.12% of the annual amount of the basic salary for the time being.

## 3.4 Telecommunications Allowance

From 1 July 2016 to 30 June 2018:

- (1) There is payable to each member of Parliament a Telecommunications Allowance.
- (2) The Telecommunications Allowance is to be paid by way of reimbursement of 90% of all charges for a mobile phone, except as outlined in subclause (3).
- (3) The Telecommunications Allowance in respect of a mobile telephone for the holder of the offices of the President of the Legislative Council, Speaker of the House of Assembly, Leader of the Opposition and Leader of a recognised non-government party, is to be paid by way of reimbursement of 100% of all charges for a mobile phone.

## 3.5 Entertainment Allowance

(1) From 1 July 2016 to 30 June 2018, there is payable to a person holding an office specified in the first column of Table D an Entertainment Allowance of an amount equivalent to the percentage of the basic salary as specified in the second column.

# 3.6 Away from Home Travelling Allowance

From 1 July 2016 to 30 June 2018:

(1) There is payable to a member of Parliament an Away From Home Travelling Allowance for expenses incurred while travelling on official parliamentary business.

- (2) The rate of and the circumstances under which the allowance is payable shall be in accordance with the Travel Allowance and Meal Allowance components prescribed from time to time by the Tasmanian State Service Award of the Commission.
- (3) Where a member of Parliament exceeds the allowance to which he or she is entitled, the member may, subject to any guidelines issued from time to time by the Government, claim an allowance by way of reimbursement of expenses, at the rate equivalent to the actual expenses incurred, on submission of documentary evidence of those expenses.
- (4) The allowances referred to in subclauses (2) and (3) are mutually exclusive and a member must claim either the allowance referred to in subclause (2) or the reimbursement of actual expenses referred to in subclause (3).

## 3.7 Bass Strait Islands Travelling Allowance

From 1 July 2016 to 30 June 2018:

- (1) There is payable to any member of Parliament travelling to the Bass Strait Islands on official parliamentary business a Bass Strait Islands Travelling Allowance.
- (2) The Bass Strait Islands Travelling Allowance is payable by way of reimbursement of expenses incurred by members of Parliament.

#### 4 Date of Effect

The date on which this Determination takes effect is 1 July 2016.

# 5 Date of Ceasing to have Effect

The date on which this Determination ceases to have effect is 30 June 2018.<sup>4</sup>

# 6 Date of Next Inquiry and Report

The date by which a report is to be provided to the Clerk of each House of Parliament in relation to a further inquiry by the Commission in accordance with section 3C(1) of the 2012 Act is 1 March 2018.
