NOTICE OF THE MAKING OF STATUTORY RULES

IN ACCORDANCE with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:—

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the *Children, Young Persons and Their Families Amendment Act 2013*

This proclamation fixes 1 July 2016 as the day on which sections 5, 6, 9, 12, 13, 14, 15, 16, 20, 21, 25, 26, 27, 28, 29, 30, 33, 34, 35 and 43 of the *Children, Young Persons and Their Families Amendment Act 2013* commence.

(2) *Health (Fees) Amendment Regulations 2016*

These regulations amend the *Health (Fees) Regulations 2007* by increasing certain fees to be charged in respect of the treatment of non-nursing-home-type patients.

(3) Proclamation under section 2 of the *Public Sector Superannuation Reform Act 2016*

This proclamation fixes 29 June 2016 as the day on which sections 1, 2, 3, 5, 20 and 22, and Parts 2 and 3, of the *Public Sector Superannuation Reform Act 2016* commence.

(4) *Tasmanian Development Order 2016*

This order amends the *Tasmanian Development Act 1983* by increasing –

- (a) the amount that Tasmania Development and Resources may lend to a person, with security, from \$1 500 000 to \$3 000 000; and

- (b) the amount that Tasmania Development and Resources may lend to a person, with or without security and with or without interest, from \$100 000 to \$250 000; and
- (c) the threshold which determines whether financial grants by Tasmania Development and Resources require the approval of the Minister, or of both the Minister and the Treasurer, from \$250 000 to \$500 000.
