LIVING MARINE RESOURCES MANAGEMENT ACT 1995

FISHERIES (SHELLFISH) RULES 2007, RULE 7

PUBLIC NOTICE – SETTING OF TOTAL ALLOWABLE CATCH (TAC), DETERMINING THE PARTS AND PORTIONS FROM WHICH THE TAC IS TO BE TAKEN FOR THE COMMERCIAL SHELLFISH FISHERY.

Pursuant to the powers under the *Fisheries (Shellfish) Rules 2007* ("the Rules") that were delegated to the Director (Marine Resources) on 19 August 2015 by the Minister acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* (the Act), pursuant to Rule 7 of the *Fisheries (Shellfish) Rules 2007*, for the 2016/2017 quota period of the commercial

shellfish fishery commencing 1 September 2016 and finishing 31 August 2017 inclusive, I hereby:

1. set the total allowable catch for the commercial shellfish fishery as:
 - 3,000 kilograms of *Venerupis* clams; 0 kilograms of *Katelysia* cockles; and 21,400 dozen native oysters;
2. determine that the parts of the commercial shellfish fishery from which the total allowable catch is to be taken are: the Georges Bay South Clam Zone; Georges Bay North Clam Zone; Ansons Bay Cockle Zone; and Georges Bay;
3. determine that the portion of total allowable catch to be taken from each part of the commercial shellfish fishery is as follows:
 - Georges Bay South Clam Zone – 0 kilograms of *Venerupis* clams;
 - Georges Bay North Clam Zone – 3,000 kilograms of *Venerupis* clams;
 - Ansons Bay Cockle Zone – 0 kilograms of *Katelysia* cockles; and,
 - Georges Bay – 21,400 dozen native oysters.

Any expression used in this public notice having a particular meaning under the Act or the Rules has the same meaning in this public notice as it has in the Act or the Rules.

ANTI-DISCRIMINATION ACT 1998

EQUAL OPPORTUNITY TASMANIA

EXEMPTION/S GRANTED

The following application for exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

1. Tasmanian Centre for Global Learning Inc auspicing Students Against Racism – 16/08/020 – Application for an exemption granted under section 57 of the Act for a period of one week from the date granted (inclusive of 18 and 19

August 2016).

This exemption has been granted to permit Students Against Racism to advertise and host a women-only 2-day event, Women's Business, for the purposes of:

- a) encouraging and supporting women of migrant, refugee and/or asylum seeker backgrounds to participate and celebrate their cultural differences through fashion and performances without fear of disrespecting their culture; and
- b) respecting the participating women's cultures by excluding men from attending the Women's Business event.

This is consistent with:

- a) section 25 of the Act, which provides an exception for discrimination 'if it is for the purpose of carrying out a scheme for the benefit of a group which is disadvantaged or has a special need because of a prescribed attribute'; and
- b) section 26 of the Act, which provides an exception for discrimination 'in any program, plan or arrangement designed to promote equal opportunity for a group of people who are disadvantaged or have a special need because of a prescribed attribute'; and
- c) section 27(1)(f) of the Act, which provides an exception for discrimination 'on the ground of gender – in the provision or use of facilities, if those facilities are reasonably required for use by persons of one gender only'.

The exemption is for the period of one week subject to the fulfilment of the conditions that Students Against Racism:

- a) report as soon as practicable after the event to the Anti-Discrimination Commissioner on the success of the event and any issues or concerns raised about this exemption; and
- b) on at least one occasion in the 6 months immediately after this order is made, organise and promote community education for the members of Students Against Racism through the Equal Opportunity Tasmania's community education program to increase awareness of rights and obligations under the *Anti-Discrimination Act 1998* (Tas).

- b) section 26 of the Act, which provides an exception for discrimination 'in any program, plan or arrangement designed to promote equal opportunity for a group of people who are disadvantaged or have a special need because of a prescribed attribute'; and
- c) section 27(1)(d) of the Act, which provides an exception for gender discrimination 'in employment, if it is based on a genuine occupational qualification or requirement in relation to a particular position'.
