This proclamation fixes 1 October 2016 as the day on which sections 10, 38, 40 and 44 of the *Children, Young Persons and Their Families Amendment Act 2013* commence.

(2) *Marine Farming Planning Regulations 2016*

These regulations –

- (a) prescribe fees and charges for the purposes of the *Marine Farming Planning Act 1995*; and
- (b) provide for the remission, or exemption from payment, of those fees and charges; and
- (c) prescribe offences for which infringement notices may be issued; and
- (d) prescribe penalties for those offences; and
- (e) are made consequent on the repeal of the *Marine Farming Planning Regulations 2006* under section 11 of the *Subordinate Legislation Act 1992*.
