(1) Guardianship and Administration Regulations 2017

 - (ii) requirements relating to special treatments and consents to medical and dental treatments under that Act; and
 - (iii) provisions relating to fees to be paid under that Act; and
- (b) are made consequentially on the repeal of the *Guardianship and Administration Regulations 2007* under section 11 of the *Subordinate Legislation Act 1992*.

(2) Health (Fees) Regulations 2017

These regulations -

- (a) prescribe the fees payable under the *Health Act 1997* for hospital services provided to certain persons in public hospitals; and
- (b) are made consequentially on the repeal of the *Health (Fees) Regulations 2007* under section 11 of the *Subordinate Legislation Act 1992*.
