Laws for tobacco products and electronic cigarettes

Parliament has passed new laws for electronic cigarettes and for licensing tobacco products. The planned start date for the new laws is 29 November 2017. Under the new laws, electronic cigarettes cannot be sold to children, sold without a licence, advertised, or used in smoke-free areas.
