I, Jeremy Rockliff, Minister administering the *Living Marine Resources Management Act 1995* (the Act), pursuant to Section 94 (2)(b) and (c) of the Act, for the quota period from 1 March 2017 to 28 February 2018, hereby:

 Determine the area of State waters adjacent to the north east coast of Tasmania bounded in the south on the north east coast by the line of latitude at 41° 16' 30" South running due east from St Helens Point and

- bounded in the north on the north coast by the line of longitude at 146° 32' 00" East running due north of Point Sorell (Port Sorell), to be the rock lobster *north east catch-cap area*; and,
- Determine that the portion of the rock lobster total allowable commercial catch to be taken from the *north* east catch-cap area is 100 tonnes.

ANTI-DISCRIMINATION ACT 1998

EQUAL OPPORTUNITY TASMANIA

EXEMPTION/S GRANTED

The following application for exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

1. Tasmanian State Service – 17/01/018 – Application for an exemption granted under section 57 of the Act for a period of three years.

This exemption has been granted to permit the Tasmanian State Service to specifically recruit and employ graduates with a disability into the Tasmanian State Service who are eligible to participate in the Graduate Program for People with Disabilities ('the Program'), on the basis that it is consistent with:

- a) section 25 of the Act, which provides an exception for discrimination 'for the purpose of carrying out a scheme for the benefit of a group which is disadvantaged or has a special need because of a prescribed attribute'; and
- b) section 26 of the Act, which provides an exception for discrimination 'for a group of people who are disadvantaged or have a special need because of a prescribed attribute'.

Granted on the 23rd day of January 2017.

The exemption is for the period of three (3) years subject to the fulfilment of the conditions that all Tasmanian State Service Departments or Agencies that employ graduates under the program:

- a) report on or before 31 July 2017 to the Anti-Discrimination Commissioner on any actions taken in reliance on this exemption; and
- b) report on or before 23 January 2020 to the Anti-Discrimination Commissioner detailing the outcomes of the Graduate Program for People with Disabilities;
- c) on at least one occasion in the 12 months immediately after this order is made, invite Equal Opportunity Tasmania to attend and present a training and education awareness session for those involved in the Program to increase awareness of rights and obligations under the Anti-Discrimination Act 1998 (Tas). This session is to be repeated each year to ensure all new graduates and managers of new graduates receive this training.

A person may apply to the Anti-Discrimination Tribunal for a review of the Commissioner's decision within 28 days from the date of this notice being published.
