Fee Units

FEE UNITS ACT 1997

The Fee Units Act 1997 provides for automatic changes in Government fees and charges in accordance with movements in the Hobart Consumer Price Index (CPI). The Fee Units Act also provides for adjustments to be made on the basis of factors other than movements in the CPI through a fee unit adjustment factor

I am satisfied that there are no special factors that would result in the increase in the costs of providing government services being less than the increase in the CPI. I, therefore, have determined the fee unit adjustment factor for 2017-18 to be zero for the purposes of section 4 of the Fee Units Act.

In accordance with section 5 of the Fee Units Act, the value of a fee unit is increased by the increase in the CPI and for 2017-18 will be \$1.55.
