#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Anatomical Examinations Order 2017

This order amends the *Anatomical Examinations Act 2006* to update the definition of *Faculty* in that Act, to refer to the Faculty of Health in the University of Tasmania.

(2) Anatomical Examinations Regulations 2017

These regulations -

- (a) prescribe, for the purposes of the Anatomical Examinations Act 2006, the records, documents and particulars that must be kept by the Head of the Faculty of Health in the University of Tasmania in relation to bodies of deceased persons accepted for anatomical examinations; and
- (b) specify, for that Act, the procedures to be undertaken while such a body is in the control of the Head of that Faculty; and
- (c) set, for that Act, the application fee for an individual authorisation to undertake anatomical examinations; and
- (d) are made consequentially on the repeal of the *Anatomical Examinations Regulations 2007* under section 11 of the *Subordinate Legislation Act 1992*.
- (3) Dangerous Goods (Road and Rail Transport) Amendment Regulations 2017

These regulations amend the *Dangerous Goods (Road and Rail Transport) Regulations 2010* to reflect changes made to the National Transport Commission's Model Subordinate Instrument on the Transport of Dangerous Goods by Road or Rail.
