#### LIVING MARINE RESOURCES MANAGEMENT ACT 1995

#### NOTIFICATION OF ALTERATION TO THE TASMANIAN ROCK LOBSTER FISHERY MANAGEMENT PLAN

I, GRANT PULLEN, Acting Director (Marine Resources) in the Department of Primary Industries, Parks, Water and Environment, pursuant to the delegated authority under Section 20(2) of the *Living Marine Resources Management Act 1995* and in accordance with section 57 of that Act, hereby notify that:

- (a) As a result of a review the Minister has accepted a recommendation to alter the management plan for the rock lobster fishery *Fisheries (Rock Lobster) Rules 2011.*
- (b) The Fisheries (Rock Lobster) Amendment Rules 2017, amend the Fisheries (Rock Lobster) Rules 2011 by:
  - making new provision for the carry-over of partially caught quota units;
  - prohibiting multiple night shots in all State waters;
  - providing an additional method for specifying a maximum number of rock lobster pots in a fishing licence (rock lobster);
  - amending Schedule 2 ( Length Tonnage Schedule);
  - requiring all fishers to make a pre fishing telephone report before commencing a fishing trip;
  - removing the requirement to make a catch cap area transit telephone report;
  - providing tighter port of landing controls by reference to catch-cap and other fishing areas;
  - amending the definition of a fishing trip;
  - limiting the possession of rock lobster retained for personal use;
  - imposing certain restrictions on the possession of unused dockets in respect of the rock lobster fishery;
  - revising provisions relating to the transfer of quota units and rock lobster pots;
  - prescribing additional wharves for landing at the ports of Dover and Stanley;
  - creating several new offences and adjusting the penalties of several existing offences;
  - · omitting redundant provisions and effecting other minor changes by way of statute law revision; and,
  - · updating infringement notice offences and penalties.
  - (c) The alterations take effect on 1 March 2017.
