PUBLIC NOTICE - DATES OF THE CLOSED SEASON FOR PART OF THE COMMERCIAL DIVE FISHERY TO THE TAKE OF PERIWINKLES (GENUS TURBO) IN STATE WATERS IN THE NORTHERN ZONE EXCLUDING KING AND FLINDERS ISLANDS

Pursuant to the powers under the Fisheries (Commercial Dive) Rules 2011 ("the Rules") that were delegated to the Director (Marine Resources) on 19 August 2015 by the Minister, acting pursuant to section 20(1) of the Living Marine Resources Management Act 1995 ("the Act"), I determine that the dates of closing of State waters of the commercial dive fishery to the take of periwinkles (Genus Turbo) in State waters in the "northern zone excluding waters around King Island and Flinders Island" to the activities of the take of periwinkles (Genus Turbo) are as follows:

from 15 March 2017 to 31 August 2017 inclusive;

where the "northern zone excluding waters around King Island and Flinders Island" is defined to mean: all State waters off the north coast of Tasmania north of an imaginary line commencing where the line of latitude 41° 00' 26" South enters the eastern limit of State waters then runs due west to the high water mark at Red Rocks then follows that line of high water in a generally western direction to Cape Grim then runs due west to the western limit of State waters but excluding State waters adjacent to King Island and Flinders Island.

The holder of a fishing licence (commercial dive) must not dive or enter the water in the "northern zone excluding waters around King Island and Flinders Island" during the closed period if in possession of periwinkles on a fishing vessel.

Any expression used in this public notice having a particular meaning under the Act or the Rules has the same meaning in this public notice as it has in the Act or the Rules.
