#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Fire Service (Finance) Regulations 2017*

These regulations prescribe certain matters for the purposes of Part VI of the *Fire Service Act 1979*, which relates to the finances of the State Fire Commission.

(2) *Forest Practices Regulations 2017*

These regulations –

- (a) prescribe the circumstances in which forest practices may be carried out without a forest practices plan; and
- (b) prescribe the fees payable under the *Forest Practices Act 1985*; and
- (c) are made consequentially on the repeal of the *Forest Practices Regulations 2007* under section 11 of the *Subordinate Legislation Act 1992*.

(3) *Long Service Leave Regulations 2017*

These regulations prescribe procedures in respect of –

- (a) the settlement of disputes relating to long service leave entitlements; and
- (b) appeals relating to decisions and determinations; and
- (c) applications for orders relating to entitlements; and
- (d) the format of long service leave records.

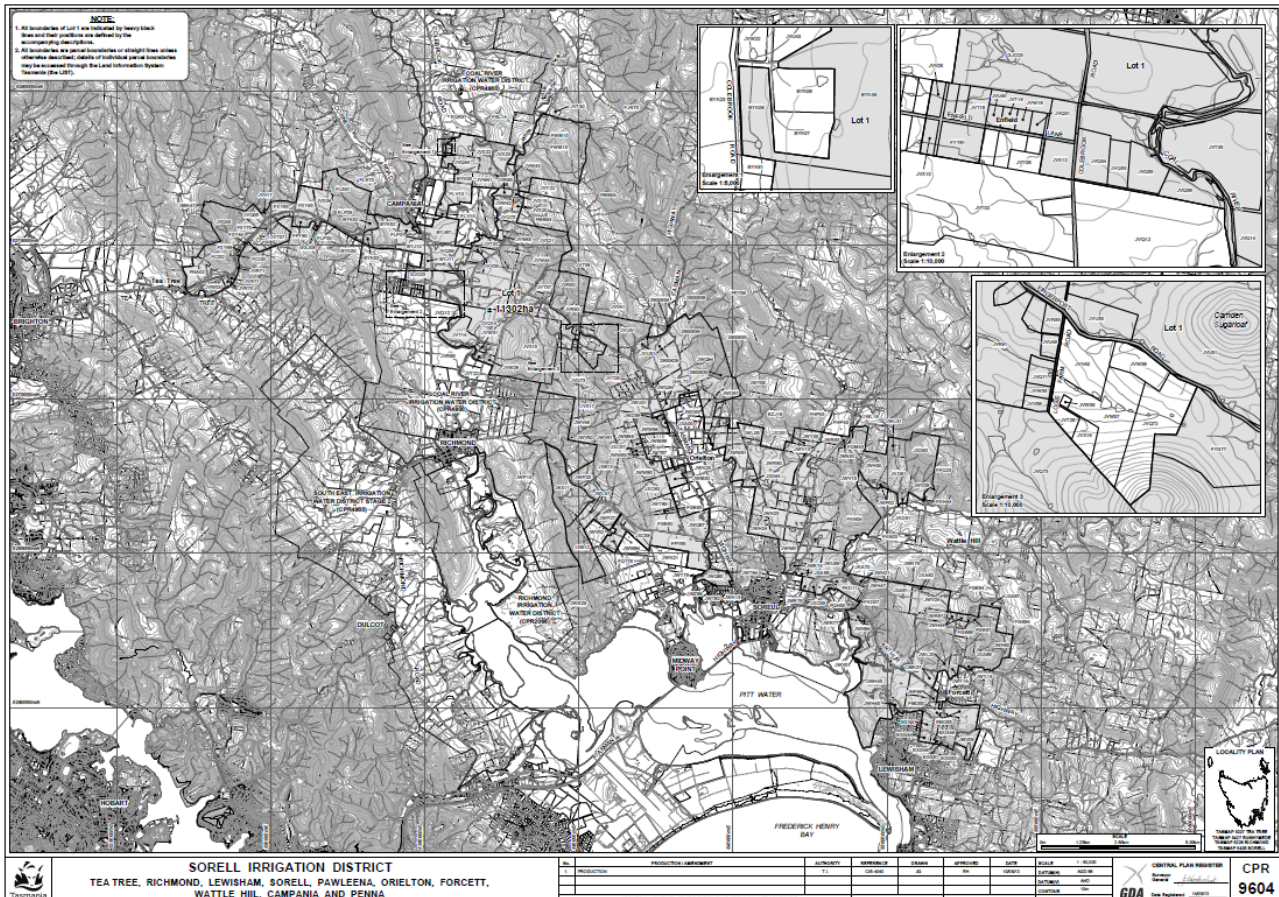

#### PUBLIC NOTICE - DATES OF OPENING AND CLOSING OF

#### THE COMMERCIAL ROCK LOBSTER FISHERY

#### RULE 11 OF THE FISHERIES (ROCK LOBSTER) RULES 2011

Pursuant to the powers under the *Fisheries (Rock Lobster) Rules 2011* ("the Rules") that were delegated to me on 19 August 2015 by the Minister acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* ("the Act"), in accordance with rule 11 of the Rules, I hereby determine that the public notice-*dates of opening and closing of the commercial rock lobster fishery* dated 18 March 2016 and published in *Gazette* No. 21 589 on 23 March 2016, is rescinded with effect on and from the date of publishing of this public notice and that:

1. the dates of the open and closed seasons for the commercial rock lobster fishery for **male** rock lobster are as follows:
  - closed season from 1 September 2017 for the "September closed region";
  - closed season from 1 October 2017 for all State waters;
  - open season from 15 November 2017 for the "western region"; and,
  - open season from 27 November 2017 for the "eastern region";
  
2. the dates of the open and closed seasons for the commercial rock lobster fishery for **female** rock lobster are as follows:
  - closed season from 1 May 2017 for all State waters;
  - open season from 15 November 2017 for the "western region"; and,
  - open season from 27 November 2017 for the "eastern region";

where:

**"September closed region"** is defined to mean State waters adjacent to the north, north east, east, south and west coasts of Tasmania enclosed by an imaginary line starting at the high water mark on the east coast of the mainland of Tasmania at longitude 41° 16' 30" East (St Helens Point), then running due east to the limit of State waters, then running in a clockwise direction at the limit of State waters until that imaginary line meets the line of latitude 41° 29' 0 South off the west coast of Tasmania (3.7NM south of Sandy Cape), then running due east to the high water mark of the mainland of Tasmania and then running in a anticlockwise direction along the high water mark of Tasmania to the starting point of that imaginary line;

and where:

**“eastern region”** is as defined in the *Fisheries (Rock Lobster) Rules 2011*; and,

**“western region”** is as defined in the *Fisheries (Rock Lobster) Rules 2011*.

Words and expressions used in this public notice have the same meaning as in the *Living Marine Resources Management Act 1995* and the *Fisheries (Rock Lobster) Rules 2011*.

**Living Marine Resources Management Act 1995****Section 48A(2)****PUBLIC NOTICE: NOTIFICATION OF CORRECTION TO MANAGEMENT PLAN FOR THE TASMANIAN SCALEFISH FISHERY**

Pursuant to the powers under section 48A(2) of the *Living Marine Resources Management Act 1995* ("the Act") that were delegated to the Director (Marine Resources) on 20 January 2016 by the Secretary acting pursuant to section 20(2) of the Act notice is hereby given that:

1. The management plan for the Tasmanian Scalefish Fishery has been corrected pursuant to section 48A(1) of the Act.
2. The corrections areas follows:

**Rule 3 corrected (Interpretation)**

Rule 3 of the Principal Rules is corrected by omitting paragraph (b) of the definition of *fishing trip* and substituting the following paragraph:

(b) ends when the vessel returns to land, a pier, jetty or artificial extension of land, with all apparatus that is on the vessel out of the water, other than a fish cauf being used in accordance with rule 118;

**Rule 34 clarified (Nature of buoys)**

Rule 34 of the Principal Rules is clarified by inserting the following subrule after subrule (3):

(4) If a person sets, or uses, apparatus that is marked with a buoy that is in addition to the buoys required under these rules for that apparatus, each additional buoy must not bear any deliberate marks other than the marks required under these rules for a marker buoy for that apparatus.

Penalty: Grade 1 penalty.

**Rule 43 corrected (Fishing license (scalefish C))**

Rule 43 of the Principal Rules is corrected by –

- (a) inserting into subrule (1) the words "at one time" after "use,"; and
- (b) omitting from subrule 1(a) "and" and substituting "or"; and
- (c) omitting from subrule 1(b) "and" and substituting "or"; and



- (d) omitting subrule 3(a) and substituting the following:
  - (a) possess on a fishing vessel –
    - (i) not more than 5 squid jigs; and
    - (ii) one hand held dip net; and
    - (iii) landing nets; and

**Rule 44 corrected (Fishing licence (rock lobster))**

Rule 44 of the Principal Rules is corrected by –

- (e) omitting subrule 1(c) and substituting the following:
  - (c) 2 fish traps; and
  - (d) 5 squid jigs.
- (f) omitting subrule (3)(a) and substituting the following:
  - (a) possess on a fishing vessel –
    - (i) not more than 2 hand held dip nets; and
    - (ii) landing nets;
- (g) omitting from subrule (3)(b) "the squid jigs and".

**Rule 57 corrected (Limits for holders of appropriate authority and scalefish licence)**

Rule 57 of the Principal Rules is corrected by omitting from subrule(1)(c) "50" and substituting "150".

**Rule 60 corrected (Taking Australian salmon in certain waters)**

Rule 60 of the Principal Rules is corrected by omitting from subrule(2)(b) "the person's" and substituting "a".

**Rule 101 clarified (Restrictions on fishing licence (limited Danish seine))**

Rule 101 of the Principal Rules is clarified by omitting subrule(2)(a) and substituting the following paragraph:

- (a) in the north by an imaginary straight line originating from Tasman Head on South Bruny Island at latitude 43°30'58"S/ longitude 147°17'40.3"E and finishing at Cape Raoul on the Tasman Peninsula at latitude 43°14'32.8"S/ longitude 147°47'58"E; and

**Schedule 6 corrected (Regions)**

Part 2 of Schedule 6 of the Principal Rules is corrected by omitting from item 2 after longitude second occurring "47" and substituting "147".

**Schedule 7 corrected (Persons permitted to use gillnet in shark refuge areas)**

Schedule 7 of the Principal Rules is corrected by inserting a space into item 1(a) after "exceeds".
