# MARINE AND SAFETY (JETTIES) BY-LAWS 2017

The Marine and Safety Authority makes the following by-laws under the *Marine and Safety Authority Act 1997*.

# 1. Short title

These by-laws may be cited as the Marine and Safety (Jetties) By-laws 2017.

# 2. Commencement

These by-laws take effect on 29 July 2017.

# 3. Interpretation

In these by-laws –

Act means the Marine and Safety Authority Act 1997;

*Authority* means the Marine and Safety Authority established under section 4 of the Act;

*berth* means –

- (a) to lie alongside a State jetty; or
- (b) to be connected or tied to a vessel lying alongside a State jetty; or
- (c) to be connected to a State jetty;

*berthing area* means any area of a State jetty that is not delineated at the kerb, fenders or edge by a yellow line;

certificate of survey or operation has the same meaning as in the National Law; *loading area* means any area of a State jetty that is delineated at the kerb, fenders or edge by a yellow line; *marine facility* means any facility, structure or equipment used in relation to the navigation and operation of vessels; National Law has the same meaning as in the Act; operator means a person in charge of, or operating, a vessel; *penalty unit* means a penalty unit within the meaning of the Penalty Units and Other Penalties Act 1987: restricted area means any area on a marine facility that is delineated at the kerb, fender or edge by a red line; rubbish means any waste material, refuse or litter, including fish waste and animal faeces; *State jetty* means any marine facility, together with any utility services, managed by the Authority; *unseaworthy* has the same meaning as in the Act: utility services means -

- (a) any services providing power, light, water or fuel to a State jetty; or
- (b) any other similar services connected to a State jetty;

*vehicle* includes any thing designed to move or to be moved on one or more wheels or revolving runners;

*vessel* has the same meaning as in the Act.

# 4. Berthing of certain vessels prohibited

A person must not berth a vessel at a State jetty, without prior approval of the Authority, unless that vessel -

- (a) has a current national certificate of survey or operation; or
- (b) is registered in accordance with the Marine and Safety (Motor Boats and Licences) By-laws 2013.
- Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty units for each day during which the offence continues.

# 5. Vessels not to exceed load rating

A person must not berth a vessel at a State jetty or part of a State jetty if that vessel exceeds the

vessel tonnage or length limit displayed for the State jetty or the part of the State jetty.

Penalty: Fine not exceeding 20 penalty units.

# 6. Loading areas

- (1) A person must not -
  - (a) berth, without prior approval of the Authority, a vessel alongside a loading area other than for the purpose of loading or unloading passengers, stores, catch or cargo; or
  - (b) leave a commercial vessel in a loading area without a competent crew on board who holds a current national certificate of competency relevant to the vessel; or
  - (c) leave a recreationally registered vessel in a loading area without a competent crew on board who holds a recreational licence in accordance with the Marine and Safety (Motor Boats and Licences) By-laws 2013; or
  - (d) leave a recreational vessel that does not require registration in accordance with the Marine and Safety (Motor Boats and Licences) By-laws 2013 alongside a loading area without a competent crew on board.
  - Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing

offence, a further penalty of 5 penalty units for each day during which the offence continues.

- (2) A person must not leave a vessel alongside a loading area once the vessel has completed loading or unloading passengers, stores, catch or cargo.
  - Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty units for each day during which the offence continues.

# 7. Restricted areas

A person must not berth a vessel alongside a restricted area at a State jetty in excess of any time limit specified by the Authority and displayed at the State jetty, without prior approval of the Authority.

Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty units for each day during which the offence continues.

# 8. Removal or relocation of vessel

(1) The Authority, by written notice, may direct the owner or operator of a vessel that is berthed at a State jetty to remove the vessel from that State jetty for a period specified by the Authority.

### c. 9

- Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty units for each day during which the offence continues.
- (2) The Authority, by written notice, may direct the owner or operator of a vessel that is berthed at part of a State jetty to move the vessel to another part of that State jetty.
  - Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty units for each day during which the offence continues.
- (3) If the owner of a vessel does not comply with a direction in a notice under subclause (1) or (2), the Authority may move or relocate the vessel.
- (4) The Authority may recover from the owner of a vessel any costs incurred in the relocation of a vessel under subclause (3) in a court of competent jurisdiction.

# 9. Vehicles on State jetties

(1) A person must not use a vehicle on a State jetty except in connection with the loading, unloading or maintenance of vessels.

Penalty: Fine not exceeding 20 penalty units.

(2) A person must not drive, park or place a vehicle on any part of a State jetty if the vehicle mass of

that vehicle exceeds the displayed gross vehicle mass in respect of that part.

Penalty: Fine not exceeding 20 penalty units.

- (3) A person must not leave a vehicle unattended on a State jetty.
  - Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty units for each day during which the offence continues.

# 10. Closure of State jetty

- (1) The Authority, by issue of a notice, may require a State jetty to be closed for a specified period –
  - (a) for a special event; or
  - (b) for the purpose of maintenance; or
  - (c) if it considers that the State jetty is unsafe.
- (2) The Authority may direct any person in charge of a vessel at, or a vehicle on, a State jetty to remove the vessel or vehicle from that State jetty for the period specified in a notice under subclause (1).
- (3) A person must not be, or remain, on a State jetty during the period specified in a notice under subclause (1).

Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty units for each day during which the offence continues.

# 11. Damage to State jetty

- A person must not damage a State jetty or its utility services by –
  - (a) causing or allowing a vessel to collide with the State jetty; or
  - (b) vandalising the State jetty; or
  - (c) loading or unloading cargo and fuel in a negligent manner; or
  - (d) graffitiing; or
  - (e) interfering with, damaging or removing any part of any utility service; or
  - (f) removing or damaging any part of a marine facility that could interfere with the safe navigation of vessels or could endanger lives.

Penalty: Fine not exceeding 30 penalty units.

(2) A person must not light a fire on a State jetty.

Penalty: Fine not exceeding 30 penalty units.

(3) A person must not attach any berthing lines to any State jetty components that are not

specifically fitted for the purpose of attaching berthing lines.

Penalty: Fine not exceeding 20 penalty units.

(4) A person in charge of a vessel berthed at a State jetty must remove that vessel from the State jetty if weather conditions are likely to cause the vessel to damage the State jetty.

Penalty: Fine not exceeding 20 penalty units.

(5) The Authority may recover the costs for repair of damage to a State jetty from a person who contravenes subclause (1), (2), (3) or (4) in a court of competent jurisdiction as a debt due to the Authority.

# 12. Rubbish on State jetty

(1) A person must not leave any rubbish on a State jetty.

Penalty: Fine not exceeding 20 penalty units.

- (2) The Authority may
  - (a) remove any rubbish left on a State jetty; and
  - (b) recover, in a court of competent jurisdiction, the reasonable costs incurred in that removal from the person who left the rubbish.

# 13. Unauthorised alteration of State jetty

(1) A person must not alter a State jetty without the written approval of the Authority.

Penalty: Fine not exceeding 30 penalty units.

(2) A person must not install any lifting device, crane or utility service on a State jetty without the written approval of the Authority.

Penalty: Fine not exceeding 30 penalty units.

- (3) The Authority may
  - (a) rectify any alteration or remove any utility service on a State jetty made or installed under subclause (1) or (2); and
  - (b) recover from the person who made the alteration or installed the utility service reasonable costs incurred for rectification of the alteration or the removal of the utility service in a court of competent jurisdiction.
- (4) A person must not erect, exhibit or display a notice, sign, bill, poster or advertisement on any State jetty without the prior approval of the Authority.

Penalty: Fine not exceeding 20 penalty units.

# 14. Utility services

The Authority may recover from a person the reasonable costs incurred by the Authority for

the use by that person of any utility service in a court of competent jurisdiction.

# 15. Obstruction of State jetty

- (1) A person must not berth a vessel or place a vehicle or any other equipment on a State jetty or use a State jetty in a manner that obstructs another vessel coming alongside or leaving the State jetty.
  - Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty units for each day during which the offence continues.
- (2) A person must not berth a vessel at a State jetty without the prior written approval of the Authority if –
  - (a) the vessel is unseaworthy; or
  - (b) work on the vessel may render it unseaworthy.

Penalty: Fine not exceeding 20 penalty units.

- (3) A person must not place or store cargo or other material on, or in such a way as to obstruct, a State jetty unless a vessel or vehicle is alongside to receive the cargo or other material.
  - Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty

units for each day during which the offence continues.

(4) A person must not fish from or near a State jetty in such a manner as to obstruct or impede vessels or vehicular or pedestrian traffic on or adjacent to the State jetty.

Penalty: Fine not exceeding 20 penalty units.

# 16. Maintenance of vessels

A person must not carry out repairs or maintenance to a vessel on a State jetty for a period in excess of 3 days without prior written approval of the Authority.

Penalty: Fine not exceeding 20 penalty units and, in the case of a continuing offence, a further penalty of 5 penalty units for each day during which the offence continues.

# **17.** Direction to leave

The Authority may direct a person to leave a State jetty if the person does not have a valid reason to be on the State jetty.

# **18.** Direction to remain

The Authority may direct the person in charge of a vessel berthed at a State jetty to remain in attendance while –

- (a) the vessel is being loaded or unloaded; or
- (b) passengers or crew are boarding or leaving the vessel.

# 19. Compliance with direction

A person must comply with a direction given by the Authority under these by-laws.

Penalty: Fine not exceeding 20 penalty units.

# 20. Commercial use

A person must not sell, let or hire any goods, vessel or property on a State jetty without prior written approval of the Authority.

Penalty: Fine not exceeding 20 penalty units.

# 21. Swimming and diving at State jetty

A person, without written approval from the Authority, must not –

- (a) swim or dive within 30 metres of a State jetty; or
- (b) jump or dive off a State jetty.

Penalty: Fine not exceeding 20 penalty units.

# 22. Exemptions

The Authority may exempt any person from any provision of these by-laws.
