GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Building Amendment Regulations 2017*

These regulations amend the *Building Regulations 2016* by –

- (a) empowering the Director of Building Control to make determinations in respect of documentary requirements, visitor accommodation, occupancy permits, temporary occupancy permits, and verification of work in relation to building certificates; and
- (b) prescribing certain offences within those regulations as infringement notice offences and specifying the applicable penalties for those offences.

(2) *Health (Fees) Amendment Regulations 2017*

These regulations amend the *Health (Fees) Regulations 2007* by increasing the fees payable by non-nursing-home-type patients in accordance with consumer price index movements and increases in certain Commonwealth benefits.

(3) Proclamation under section 2 of the *Mental Health Amendment Act 2016*

This proclamation fixes 1 July 2017 as the day on which the *Mental Health Amendment Act 2016* commences.

(4) *Plant Quarantine Regulations 2017*

These regulations prescribe, for the purposes of the *Plant Quarantine Act 1997* –

- (a) the fees and charges payable under that Act; and
- (b) the infringement notice penalties payable in respect of certain offences under that Act.

(5) *Status of Children (Parentage Testing) Regulations 2017*

These regulations –

- (a) specify the prescribed medical procedures that are parentage testing procedures; and
- (b) provide for the collection of bodily samples; and
- (c) provide for the carrying out of parentage testing procedures; and
- (d) are made consequentially on the repeal of the *Status of Children (Parentage Testing) Regulations 2007* under section 11 of the *Subordinate Legislation Act 1992*.

(6) Proclamation under section 20(9) of the *Valuation of Land Act 2001*

This proclamation, made under the *Valuation of Land Act 2001*, fixes 1 July 2017 as the date on and after which fresh valuations of land come into force for the municipal areas of Derwent Valley, Dorset, Flinders, Glamorgan-Spring Bay, Glenorchy, King Island, Launceston, Sorell, Tasman and Waratah-Wynyard.

(7) *Water Management Amendment Regulations 2017*

These regulations amend the *Water Management Regulations 2009* by –

- (a) revising the prescribed competencies that an applicant for a class 1 licence, class 2 licence or class 3 licence must satisfy for the purposes of section 136C(2)(d) of the *Water Management Act 1999*; and
- (b) revising certain provisions relating to –
 - (i) the fees payable by a water authority; and
 - (ii) the rights of a person to take water; and
 - (iii) the prescribed requirements to which the rules of a trust must conform.
