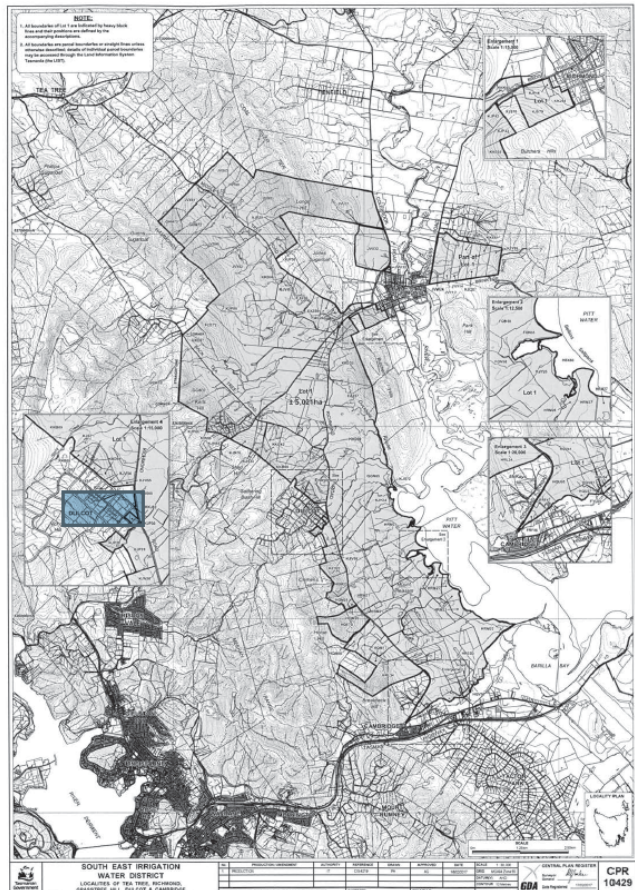

### RULES PUBLICATION ACT 1953

#### NOTICE OF THE MAKING OF STATUTORY RULES

IN ACCORDANCE with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:—

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Road Amendment (Safe Cycling) Rules 2017*

These rules amend the *Road Rules 2009* to –

- (a) provide a minimum distance that a driver of a motor vehicle must maintain from a bicycle travelling in the same direction when passing that bicycle; and
- (b) provide that a rider of a bicycle who is at a children's crossing, marked foot crossing or pedestrian crossing may cross that crossing in certain circumstances and when complying with certain conditions; and
- (c) provide that a driver of a motor vehicle must give way to a rider of a bicycle on certain marked foot crossings, children's crossings and pedestrian crossings; and
- (d) remove an exemption relating to the wearing of a seatbelt that was incorrectly included in the *Road Rules 2009*.

(2) *Traffic (Compliance and Enforcement) Amendment (Safe Cycling) Regulations 2017*

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* to –

- (a) prescribe for the purposes of Part IVB of the *Traffic Act 1925* certain offences under the *Road Rules 2009* that relate to safe cycling; and
- (b) remove from the offences prescribed for the purposes of Part IVB of the *Traffic Act 1925* certain offences under the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010* that relate to the display of registration labels; and
- (c) correct some references to rules in the notes contained in Schedule 1.
