#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Vehicle and Traffic (Vehicle Standards) Amendment Regulations 2018*

These regulations amend the *Vehicle and Traffic (Vehicle Standards) Regulations 2014* by updating vehicle standards in relation to –

- (a) modifications to light motor vehicles; and
- (b) specified horns, alarms, lights, tinting and signs fitted to certain vehicles; and
- (c) emissions from and exhausts fitted to certain vehicles; and
- (d) vehicles powered by specified alternative fuel sources.

(2) *Vehicle and Traffic (Vehicle Operations) Amendment Regulations 2018*

These regulations amend the *Vehicle and Traffic (Vehicle Operations) Regulations 2014* by specifying certain additional fittings which may be excluded, in certain circumstances, when calculating the width of a vehicle.

(3) *Traffic (Compliance and Enforcement) Amendment Regulations 2018*

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* to update offences for which infringement notices may be issued under the *Vehicle and Traffic (Vehicle Standards) Regulations 2014* as amended by the *Vehicle and Traffic (Vehicle Standards) Amendment Regulations 2018*.

(4) *Local Government (General) Amendment Regulations (No. 3) 2018*

These regulations amend the *Local Government (General) Regulations 2015* to provide for the payment of an allowance to the deputy mayor when acting in the role of mayor for 4 consecutive weeks or more.
