LIVING MARINE RESOURCES MANAGEMENT ACT 1995

Section 94

Public Notice – Total Allowable Catch for the abalone fishery 2019

Definition of the parts of the abalone fishery and the portion of the total allowable catch to be taken in each part in 2019

- I, Guy Barnett, Minister for Primary Industries and Water administering the *Living Marine Resources Management Act 1995*, acting under Section 94 of that Act, hereby:
- 1. Set the total allowable catch for the entire commercial abalone fishery for the year 2019 at 1,267 tonnes.
- 2. Determine that the parts of the commercial abalone fishery from which the total allowable catch for the year 2019 is to be taken are: I. The eastern blacklip abalone part of the fishery; II. The western blacklip abalone part of the fishery; IV. The northern blacklip abalone part of the fishery; IV. The Bass Strait blacklip abalone part of the fishery; and V. The greenlip abalone part of the fishery, those parts of the fishery being respectively identified as follows:
  - I. the eastern blacklip abalone part of the fishery is the part of the commercial abalone fishery involving only blacklip abalone in State waters adjacent to the east, south-east and south coasts of Tasmania bounded in the north by an imaginary line starting from the northern side of the mouth of the Great Musselroe River at Musselroe Bay, running due west for 100 metres, following the shoreline 100 metres from shore to the northernmost tip of Musselroe Point, running due north until intersection with the line of latitude 40°48' 00" South and running due east to the outer limit of State waters and bounded in the south by an imaginary straight line running due south from Whale Head near South East Cape to the outer limit of State waters;
  - II. the western blacklip abalone part of the fishery is the part of the commercial abalone fishery involving only blacklip abalone in State waters adjacent to the south and west coasts of the mainland of Tasmania between an imaginary straight line due south from Whale Head near South East Cape and an imaginary straight line due west from the mouth of the Wild Wave River near Sandy Cape;
  - III. the northern blacklip abalone part of the fishery is the part of the commercial abalone fishery involving only blacklip abalone in State waters adjacent to the north, north-west and north-east coasts of the mainland of Tasmania and King Island bounded in the east by an imaginary line from the northern side of the mouth of the Great Musselroe River at Musselroe Bay running due west for 100 metres, then following the shoreline 100 metres from shore to the northernmost tip of Musselroe Point, then running due north until intersection with the line of latitude 40° 48' 00" South, and running due east to the outer limit of State waters, and bounded in the west by an imaginary straight line running due west from the mouth of the Wild Wave River near Sandy Cape to the outer limit of State waters but excluding those waters within the Bass Strait blacklip abalone part of the fishery;

- IV. the Bass Strait blacklip abalone part of the fishery is the part of the commercial abalone fishery involving only blacklip abalone in State waters adjacent to the north coast of Tasmania, the Furneaux Group of islands, and in Bass Strait bounded in the west by an imaginary line running from the northernmost point of Woolnorth Point to the point of latitude 40° 37' 14.40" South, longitude 144° 41' 37.87" East, then running due north to the outer limit of State waters and bounded in the east by an imaginary line beginning where the line of longitude 147° 27' 00" East meets the high-water mark of the north coast of the mainland of Tasmania in Anderson Bay then running due north until its junction with the line of latitude 40° 39' South then due east along that line of latitude to the limit of State waters; and
- V. the greenlip abalone part of the fishery is the part of the commercial abalone fishery involving only greenlip abalone.
- 3. Determine that the portion of the total allowable catch to be taken from each part of the commercial abalone fishery for the year 2019 is:
  - the eastern blacklip abalone part of the fishery 252 tonnes;
  - II. the western blacklip abalone part of the fishery 717.5 tonnes:
  - III. the northern blacklip abalone part of the fishery 98 tonnes;
  - IV. the Bass Strait blacklip abalone part of the fishery 91 tonnes; and,
  - V. the greenlip abalone part of the fishery 108.5 tonnes.
- 4. Determine that the amount of abalone which may be taken from each part of the fishery pursuant to each abalone quota unit in the year 2019 is:
  - for the eastern blacklip abalone part of the fishery 72 kilograms;
  - II. for the western blacklip abalone part of the fishery 205 kilograms;
  - III. for the northern blacklip abalone part of the fishery 28 kilograms;
  - IV. for the Bass Strait blacklip abalone part of the fishery 26 kilograms; and,
  - V. for the greenlip abalone part of the fishery 31 kilograms.

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

# (1) Legal Profession Regulations 2018

These regulations, which replace the Legal Profession Regulations 2008, prescribe a range of matters for the purposes of the Legal Profession Act 2007, including –

- (a) matters relating to entitlement to practise; and
- (b) matters relating to professional conduct; and
- (c) practising certificate fees; and
- (d) matters relating to the handling of trust money and the keeping of trust accounts and records; and
- (e) matters relating to the disclosure of costs to clients and the assessment of costs; and
- (f) Solicitors' Trust protocols; and
- (g) forms.
- (2) Boundary Fences Regulations 2018

These regulations -

- (a) prescribe forms for the purposes of section 9 of the Boundary Fences Act 1908; and
- (b) are made consequentially on the repeal of the *Boundary Fences Regulations 2008* under section 11 of the *Subordinate Legislation Act 1992*.
- (3) Work Health and Safety Amendment Regulations 2018

These regulations amend the *Work Health and Safety Regulations 2012* by implementing nationally agreed changes to the model Work Health and Safety Regulations including –

- (a) amending the definitions of "concrete placing boom", "lift", "pressure piping", "tower crane" and "turbine"; and
- (b) removing the requirement for certain notifications to the regulator to be in writing; and
- (c) correcting references; and
- (d) making other minor amendments.
- (4) Forest Practices Order 2018

This order amends the *Forest Practices Act 1985* to update the reference to the Forest Practices Advisory Council to refer to Tasmanian Sawmillers Association Limited (ACN 052 144 797).

- (5) Proclamation under section 2 of the Road Safety (Alcohol and Drugs) Amendment Act 2017
  - This proclamation fixes 3 December 2018 as the day on which the Road Safety (Alcohol and Drugs) Amendment Act 2017 commences.
- (6) Road Safety (Alcohol and Drugs) Regulations 2018

These regulations, for the purposes of the Road Safety (Alcohol and Drugs) Act 1970 (and, by extension, the Marine Safety (Misuse of Alcohol) Act 2006 and the Rail Safety National Law (Tasmania) Act 2012) –

- (a) prescribe -
  - (i) the method of taking, labelling and keeping of blood samples and oral fluid samples; and
  - (ii) the procedure for the maintenance, testing and use of breath analysing instruments; and
  - (iii) the offences for which an infringement notice may be issued; and
  - (iv) certain drugs as illicit drugs for the purposes of the Act; and
  - (v) the qualifications and experience required for approved analysts and qualified persons; and
  - (vi) other related matters; and
- (b) rescind the Road Safety (Alcohol and Drugs) Regulations 2009 and its amending regulations.
